JOINT RESOLUTION

Making continuing appropriations for the National Nuclear Security Administration for fiscal year 2014, and for other purposes.

1 *Resolved by the Senate and House of Representatives*
2 *of the United States of America in Congress assembled,*
3 That the following sums are hereby appropriated, out of
4 any money in the Treasury not otherwise appropriated,
5 and out of applicable corporate or other revenues, receipts,
6 and funds, for the National Nuclear Security Administra-
7 tion for fiscal year 2014, and for other purposes, namely:
8 SEC. 101. (a) Such amounts as may be necessary,
9 at a rate for operations as provided in the Full-Year Con-

1 tinuing Appropriations Act, 2013 (division F of Public
2 Law 113–6) and under the authority and conditions pro-
3 vided in such Act, for continuing projects or activities (in-
4 cluding the costs of direct loans and loan guarantees) of
5 the National Nuclear Security Administration that are not
6 otherwise specifically provided for in this joint resolution
7 or in the Pay Our Military Act of September 30, 2013,
8 that were conducted in fiscal year 2013, and for which
9 appropriations, funds, or other authority were made avail-
10 able by such Act under the following headings:

11 (1) “Weapons Activities”.

12 (2) “Defense Nuclear Nonproliferation”.

13 (3) “Naval Reactors”.

14 (4) “Office of the Administrator”.

15 (b) The rate for operations provided by subsection (a)
16 for each account shall be calculated to reflect the full
17 amount of any reduction required in fiscal year 2013 pur-
18 suant to—

19 (1) any provision of division G of the Consoli-
20 dated and Further Continuing Appropriations Act,
21 2013 (Public Law 113–6), including section 3004;
22 and

23 (2) the Presidential sequestration order dated
24 March 1, 2013, except as attributable to budget au-

1 thority made available by the Disaster Relief Appro-
2 priations Act, 2013 (Public Law 113–2).

3 SEC. 102. Appropriations made by section 101 shall
4 be available to the extent and in the manner that would
5 be provided by the pertinent appropriations Act.

6 SEC. 103. Unless otherwise provided for in this joint
7 resolution or in the applicable appropriations Act for fiscal
8 year 2014, appropriations and funds made available and
9 authority granted pursuant to this joint resolution shall
10 be available until whichever of the following first occurs:
11 (1) the enactment into law of an appropriation for any
12 project or activity provided for in this joint resolution; (2)
13 the enactment into law of the applicable appropriations
14 Act for fiscal year 2014 without any provision for such
15 project or activity; or (3) December 15, 2013.

16 SEC. 104. Expenditures made pursuant to this joint
17 resolution shall be charged to the applicable appropriation,
18 fund, or authorization whenever a bill in which such appli-
19 cable appropriation, fund, or authorization is contained is
20 enacted into law.

21 SEC. 105. This joint resolution shall be implemented
22 so that only the most limited funding action of that per-
23 mitted in the joint resolution shall be taken in order to
24 provide for continuation of projects and activities.

1 SEC. 106. Amounts made available under section 101
2 for civilian personnel compensation and benefits in each
3 department and agency may be apportioned up to the rate
4 for operations necessary to avoid furloughs within such de-
5 partment or agency, consistent with the applicable appro-
6 priations Act for fiscal year 2013, except that such author-
7 ity provided under this section shall not be used until after
8 the department or agency has taken all necessary actions
9 to reduce or defer non-personnel-related administrative ex-
10 penses.

11 SEC. 107. It is the sense of Congress that this joint
12 resolution may also be referred to as the “Nuclear Weapon
13 Security & Non-Proliferation Act”.

14 This joint resolution may be cited as the “National
15 Nuclear Security Administration Continuing Appropria-
16 tions Resolution, 2014”.
