## AN ACT

To provide for the conveyance of the Forest Service Lake Hill Administrative Site in Summit County, Colorado.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

#### 1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the "Lake Hill Administra-3 tive Site Affordable Housing Act".

#### **SEC. 2. DEFINITIONS.** 4

5 In this Act:

(1) COUNTY.—The term "County" means Sum-6 7 mit County, Colorado.

8 (2) LAKE HILL ADMINISTRATIVE SITE.—The 9 term "Lake Hill Administrative Site" means the 10 parcel of approximately 40 acres of National Forest 11 System land in the County, as depicted on the map 12 entitled "Lake Hill Administrative Site" and dated 13 June 2012.

(3) SECRETARY.—The term "Secretary" means 14 15 the Secretary of Agriculture.

16 SEC. 3. CONVEYANCE OF FOREST SERVICE LAKE HILL AD-17 MINISTRATIVE SITE, SUMMIT COUNTY, COLO-18

RADO.

19 (a) CONVEYANCE AUTHORITY.—Upon receipt of an 20 offer from the County in which the County agrees to the 21 condition imposed by subsection (c), the Secretary shall 22 use the authority provided by the Forest Service Facility Realignment and Enhancement Act of 2005 (Public Law 23 24 109–54; 16 U.S.C. 580d note) to convey to the County all right, title, and interest of the United States in and 25 26 to the Forest Service Lake Hill Administrative Site.

1 (b) APPLICATION OF LAW.—

2 (1) TREATMENT AS ADMINISTRATIVE SITE.—
3 The Lake Hill Administrative Site is considered to
4 be an administrative site under section 502(1)(A) of
5 the Forest Service Facility Realignment and En6 hancement Act of 2005 (Public Law 109–54; 16
7 U.S.C. 580d note).

8 (2) EXCEPTION.—Section 502(1)(C) of that
9 Act does not apply to the conveyance of the Lake
10 Hill Administrative Site.

(c) COSTS.—The County shall be responsible for
processing and transaction costs related to the direct sale
under subsection (a).

(d) PROCEEDS.—Proceeds received from the conveyance pursuant to subsection (a) shall be available, without
further appropriation and until expended, for capital improvement and maintenance of Forest Service facilities in
Region 2 of the United States Forest Service.
