A BILL

To amend the Equal Credit Opportunity Act to prohibit discrimination on account of sexual orientation or gender identity when extending credit.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Freedom from Dis-
5 crimination in Credit Act of 2013”.

1 **SEC. 2. PROHIBITION AGAINST DISCRIMINATION ON AC-**
2 **COUNT OF SEXUAL ORIENTATION OR GEN-**
3 **DER IDENTITY.**

4 Subsection (a)(1) of section 701 of the Equal Credit
5 Opportunity Act (15 U.S.C. 1691) is amended—

6 (1) by striking “on the basis of race, color, reli-
7 gion, national origin, sex or marital status,”; and

8 (2) by inserting “on the basis of race, color, re-
9 ligion, national origin, sex, sexual orientation, gender
10 identity, or marital status,”.

11 **SEC. 3. DEFINITIONS.**

12 Section 702 of the Equal Credit Opportunity Act (15
13 U.S.C. 1691a) is amended—

14 (1) by striking subsections (f) and (g); and

15 (2) by inserting after subsection (e) the fol-
16 lowing new subsections:

17 “(f) The term ‘gender identity’ means the gender-re-
18 lated identity, appearance, or mannerisms or other gen-
19 der-related characteristics of an individual, with or with-
20 out regard to the individual’s designated sex at birth.

21 “(g) The term ‘person’ means a natural person, a
22 corporation, government or governmental subdivision or
23 agency, trust, estate, partnership, cooperative, or associa-
24 tion.

25 “(h) The term ‘sexual orientation’ means homosex-
26 uality, heterosexuality, or bisexuality.

1 “(i) Any reference to any requirement imposed under
2 this title or any provision of this title shall be deemed to
3 include a reference to the regulations of the Bureau under
4 this title or the provision of this title in question.”.
