which was referred to the Committee on Financial Services

## A BILL

To require the Secretary of the Treasury to mint coins  
in commemoration of the centennial of World War I.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “World War I American  
5 Veterans Centennial Commemorative Coin Act”.

6       **SEC. 2. FINDINGS; PURPOSE.**

7       (a) FINDINGS.—The Congress finds the following:

8               (1) The year 2018 is the 100th anniversary of  
9       the signing of the armistice with Germany ending  
10       World War I battlefield hostilities.

1           (2) On the 6th of April 1917, the United States  
2 of America entered World War I by declaring war  
3 against Germany.

4           (3) Two million American soldiers served over-  
5 seas during World War I.

6           (4) More than four million men and women  
7 from the United States served in uniform during  
8 World War I.

9           (5) The events of 1914 through 1918 shaped  
10 the world and the lives of millions of people for dec-  
11 ades.

12           (6) Over 9 million soldiers worldwide lost their  
13 lives between 1914 and 1918.

14           (7) The centennial of America’s involvement in  
15 World War I offers an opportunity for people in the  
16 United States to commemorate the commitment of  
17 their predecessors.

18           (8) Frank Buckles, the last American veteran  
19 from World War I died on February 27, 2011.

20           (9) He was our last direct American link to the  
21 “war to end all wars”.

22           (10) While other great conflicts, including the  
23 Civil War, World War II, the Korean War, and the  
24 Vietnam War, have all been memorialized on United  
25 States commemorative coins, there currently exists

1 no coin to honor the brave veterans of World War  
2 I.

3 (11) The 112th Congress established the World  
4 War I Centennial Commission to plan, develop, and  
5 execute programs, projects, and activities to com-  
6 memorate the centennial of World War I.

7 (b) PURPOSE.—The purpose of this Act is to—

8 (1) commemorate the centennial of America’s  
9 involvement in World War I; and

10 (2) honor the over 4 million men and women  
11 from the United States who served during World  
12 War I.

13 **SEC. 3. COIN SPECIFICATIONS.**

14 (a) \$1 SILVER COINS.—The Secretary of the Treas-  
15 ury (hereafter in this Act referred to as the “Secretary”)  
16 shall mint and issue not more than 350,000 \$1 coins in  
17 commemoration of the centennial of America’s involve-  
18 ment in World War I, each of which shall—

19 (1) weigh 26.73 grams;

20 (2) have a diameter of 1.500 inches (38.1 milli-  
21 meters); and

22 (3) contain 90 percent silver and 10 percent  
23 copper.

1 (b) LEGAL TENDER.—The coins minted under this  
2 Act shall be legal tender, as provided in section 5103 of  
3 title 31, United States Code.

4 (c) NUMISMATIC ITEMS.—For purposes of sections  
5 5134 and 5136 of title 31, United States Code, all coins  
6 minted under this Act shall be considered to be numis-  
7 matic items.

8 **SEC. 4. DESIGN OF COINS.**

9 (a) DESIGN REQUIREMENTS.—

10 (1) IN GENERAL.—The design of the coins  
11 minted under this Act shall be emblematic of the  
12 centennial of America’s involvement in World War I.

13 (2) DESIGNATION AND INSCRIPTIONS.—On  
14 each coin minted under this Act, there shall be—

15 (A) a designation of the value of the coin;

16 (B) an inscription of the year “2018”; and

17 (C) inscriptions of the words “Liberty”,

18 “In God We Trust”, “United States of Amer-

19 ica”, and “E Pluribus Unum”.

20 (b) SELECTION.—The design for the coins minted  
21 under this Act shall be selected by the Secretary based  
22 on the winning design from a juried, compensated design  
23 competition described under subsection (c).

24 (c) DESIGN COMPETITION.—The Secretary shall hold  
25 a competition and provide compensation for its winner to

1 design the obverse and reverse of the coins minted under  
2 this Act. The competition shall be held in the following  
3 manner:

4 (1) The competition shall be judged by an ex-  
5 pert jury chaired by the Secretary and consisting of  
6 3 members from the Citizens Coinage Advisory Com-  
7 mittee who shall be elected by such Committee and  
8 3 members from the Commission of Fine Arts who  
9 shall be elected by such Commission.

10 (2) The Secretary shall determine compensation  
11 for the winning design, which shall be not less than  
12 \$5,000.

13 (3) The Secretary may not accept a design for  
14 the competition unless a plaster model accompanies  
15 the design.

16 **SEC. 5. ISSUANCE OF COINS.**

17 (a) **QUALITY OF COINS.**—Coins minted under this  
18 Act shall be issued in uncirculated and proof qualities.

19 (b) **MINT FACILITY.**—Only one facility of the United  
20 States Mint may be used to strike any particular quality  
21 of the coins minted under this Act.

22 (c) **PERIOD FOR ISSUANCE.**—The Secretary may  
23 issue coins under this Act only during the calendar year  
24 beginning on January 1, 2018.

1 **SEC. 6. SALE OF COINS.**

2 (a) SALE PRICE.—The coins issued under this Act  
3 shall be sold by the Secretary at a price equal to the sum  
4 of—

5 (1) the face value of the coins;

6 (2) the surcharge provided in section 7 with re-  
7 spect to such coins; and

8 (3) the cost of designing and issuing the coins  
9 (including labor, materials, dies, use of machinery,  
10 overhead expenses, marketing, and shipping).

11 (b) BULK SALES.—The Secretary shall make bulk  
12 sales of the coins issued under this Act at a reasonable  
13 discount.

14 (c) PREPAID ORDERS.—

15 (1) IN GENERAL.—The Secretary shall accept  
16 prepaid orders for the coins minted under this Act  
17 before the issuance of such coins.

18 (2) DISCOUNT.—Sale prices with respect to pre-  
19 paid orders under paragraph (1) shall be at a rea-  
20 sonable discount.

21 **SEC. 7. SURCHARGES.**

22 (a) IN GENERAL.—All sales of coins issued under this  
23 Act shall include a surcharge of \$10 per coin.

24 (b) DISTRIBUTION.—Subject to section 5134(f) of  
25 title 31, United States Code, all surcharges received by  
26 the Secretary from the sale of coins issued under this Act

1 shall be paid by the Secretary to the World War I Centen-  
2 nial Commission, consistent with section 8.

3 (c) UNUSED FUNDS UPON TERMINATION.—If, upon  
4 the termination of the World War I Centennial Commis-  
5 sion, there remains a balance of funds from surcharges  
6 received from the Secretary pursuant to this section, the  
7 Commission shall transfer such funds to the general fund  
8 of the Treasury.

9 (d) AUDITS.—The Comptroller General of the United  
10 States shall have the right to examine such books, records,  
11 documents, and other data of the World War I Commis-  
12 sion as may be related to the expenditures of amounts paid  
13 under subsection (b).

14 (e) LIMITATION.—Notwithstanding subsection (a), no  
15 surcharge may be included with respect to the issuance  
16 under this Act of any coin during a calendar year if, as  
17 of the time of such issuance, the issuance of such coin  
18 would result in the number of commemorative coin pro-  
19 grams issued during such year to exceed the annual 2  
20 commemorative coin program issuance limitation under  
21 section 5112(m)(1) of title 31, United States Code. The  
22 Secretary may issue guidance to carry out this subsection.

23 **SEC. 8. FINANCIAL ASSURANCES.**

24 The Secretary shall take such actions as may be nec-  
25 essary to ensure that—

1           (1) minting and issuing coins under this Act  
2 will not result in any net cost to the United States  
3 Government; and

4           (2) no funds, including applicable surcharges,  
5 shall be disbursed to any recipient designated in sec-  
6 tion 7 until the total cost of designing and issuing  
7 all of the coins authorized by this Act (including  
8 labor, materials, dies, use of machinery, overhead ex-  
9 penses, marketing, and shipping) is recovered by the  
10 United States Treasury, consistent with sections  
11 5112(m) and 5134(f) of title 31, United States  
12 Code.
