# **A BILL**

To expedite the planning and implementation of salvage timber sales as part of Forest Service and Department of the Interior restoration and rehabilitation activities for lands within the Stanislaus National Forest and Yosemite National Park and Bureau of Land Management lands adversely impacted by the 2013 Rim Fire in California.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Rim Fire Emergency*  
5 *Salvage Act”.*

6 **SEC. 2. EXPEDITED SALVAGE TIMBER SALES IN RESPONSE**  
7 **TO THE CALIFORNIA RIM FIRE.**

8        (a) *SALVAGE TIMBER SALES REQUIRED.*—*As part of*  
9 *the restoration and rehabilitation activities undertaken on*  
10 *the lands within the Stanislaus National Forest and the*  
11 *Bureau of Land Management lands adversely impacted by*  
12 *the 2013 Rim Fire in California, the Secretary of Agri-*  
13 *culture, with respect to affected Stanislaus National Forest*  
14 *lands, and the Secretary of the Interior, with respect to af-*  
15 *ected Bureau of Land Management lands, shall promptly*  
16 *plan and implement salvage timber sales of dead, damaged,*  
17 *or downed timber resulting from that wildfire.*

18        (b) *EXPEDITED IMPLEMENTATION.*—

19            (1) *LEGAL SUFFICIENCY.*—*Due to the extraor-*  
20 *dinary severity of the Rim Fire occurring on the Fed-*  
21 *eral lands described in subsection (a), salvage timber*  
22 *sales conducted under such subsection shall proceed*  
23 *immediately and to completion notwithstanding any*  
24 *other provision of law, including the National Envi-*  
25 *ronmental Policy Act of 1969 (42 U.S.C. 4321 et*

1       *seq.*), *section 14 of the National Forest Management*  
2       *Act of 1976 (16 U.S.C. 472a)*, *the Forest and Range-*  
3       *land Renewable Resources Planning Act of 1974 (16*  
4       *U.S.C. 1600 et seq.)*, *and the Federal Land Policy*  
5       *and Management Act of 1976 (43 U.S.C. 1701 et*  
6       *seq.)*.

7               (2) *ADMINISTRATIVE AND JUDICIAL REVIEW.—*  
8       *Salvage timber sales conducted under subsection (a)*  
9       *shall not be subject to—*

10               (A) *administrative review, including, in the*  
11               *case of the Forest Service, the notice, comment,*  
12               *and appeal requirements of section 322 of the*  
13               *Department of the Interior and Related Agencies*  
14               *Appropriations Act, 1993 (Public Law 102–381;*  
15               *16 U.S.C. 1612 note); or*

16               (B) *judicial review in any court of the*  
17               *United States.*

Amend the title so as to read: “A bill to expedite the planning and implementation of salvage timber sales as part of Forest Service and Department of the Interior restoration and rehabilitation activities for lands within the Stanislaus National Forest and Bureau of Land Management lands adversely impacted by the 2013 Rim Fire in California.”.
