- 12 to award the Medal of Honor under section 3741 of such
- 13 title to Bennie G. Adkins of the United States Army for
- 14 the acts of valor during the Vietnam Conflict described
- 15 in subsection (b).
- 16 (b) Acts of Valor Described.—The acts of valor
- 17 referred to in subsection (a) are the actions of then Ser-
- 18 geant First Class Bennie G. Adkins of the United States
- 19 Army serving with Special Forces Detachment A-102
- 20 from March 9 to 12, 1966, during the Vietnam Conflict
- 21 for which he was originally awarded the Distinguished
- 22 Service Cross.

10	garding whom the Secretary of Defense submitted, before					
11	January 1, 2014, a recommendation to the President that
