## A BILL

To amend the War Powers Resolution to limit the use of funds for introduction of the Armed Forces into hostilities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “War Powers Reform  
5 Act”.

1 **SEC. 2. PURPOSE AND POLICY.**

2 Section 2(c) of the War Powers Resolution (50  
3 U.S.C. 1541(c)) is amended—

4 (1) in the matter preceding paragraph (1), by  
5 striking “are exercised” and inserting “may be exer-  
6 cised”; and

7 (2) in paragraph (3), by inserting after “at-  
8 tack” the following: “or imminent threat of attack”.

9 **SEC. 3. CONSULTATION AND REPORTING.**

10 Section 3 of the War Powers Resolution (50 U.S.C.  
11 1542) is amended—

12 (1) in the heading, by inserting “AND REPORT-  
13 ING” after “CONSULTATION”;

14 (2) by striking “The President” and inserting  
15 the following:

16 “(a) CONSULTATION.—The President”; and

17 (3) by adding at the end the following:

18 “(b) REPORTING.—The President in every possible  
19 instance shall submit to Congress before introducing  
20 United States Armed Forces into hostilities or into situa-  
21 tions where imminent involvement in hostilities is clearly  
22 indicated by the circumstances a report, in writing, setting  
23 forth the estimated scope and duration of the hostilities  
24 or involvement.”.

1 **SEC. 4. REPORTING.**

2 Section 4(a) of the War Powers Resolution (50  
3 U.S.C. 1543(a)) is amended by inserting “or a specific  
4 statutory authorization” after “a declaration of war”.

5 **SEC. 5. LIMITATION ON USE OF FUNDS FOR INTRODUCTION**  
6 **OF ARMED FORCES INTO HOSTILITIES.**

7 The War Powers Resolution (50 U.S.C. 1541 et seq.)  
8 is amended—

9 (1) by striking sections 5, 6, and 7;

10 (2) by redesignating sections 8, 9, and 10 as  
11 sections 6, 7, and 8, respectively; and

12 (3) by inserting after section 4 the following:

13 “LIMITATION ON USE OF FUNDS

14 “SEC. 5. (a) No funds available for the United States  
15 Armed Forces may be obligated or expended for introduc-  
16 tion of the Armed Forces into hostilities, or into situations  
17 where imminent involvement in hostilities is clearly indi-  
18 cated by the circumstances, in the absence of a declaration  
19 of war, specific statutory authorization, or a national  
20 emergency created by an attack or imminent threat of at-  
21 tack upon the United States, its territories or possessions,  
22 or the Armed Forces.

23 “(b) It shall not be in order in the House of Rep-  
24 resentatives or the Senate to consider any bill or joint res-

1 olution that would make funds available in violation of  
2 subsection (a).”.
