3 **SECTION 1. EXTENSION OF ENFORCEMENT INSTRUCTION**
4 **ON SUPERVISION REQUIREMENTS FOR OUT-**
5 **PATIENT THERAPEUTIC SERVICES IN CRIT-**
6 **ICAL ACCESS AND SMALL RURAL HOSPITALS**
7 **THROUGH 2014.**

8 The Secretary of Health and Human Services shall
9 continue to apply through calendar year 2014 the enforce-
10 ment instruction described in the notice of the Centers for
11 Medicare & Medicaid Services entitled “Enforcement In-
12 struction on Supervision Requirements for Outpatient
13 Therapeutic Services in Critical Access and Small Rural
14 Hospitals for CY 2013”, dated November 1, 2012 (pro-
15 viding for an exception to the restatement and clarification
16 under the final rulemaking changes to the Medicare hos-
17 pital outpatient prospective payment system and calendar
18 year 2009 payment rates (published in the Federal Reg-
19 ister on November 18, 2008, 73 Fed. Reg. 68702 through
20 68704) with respect to requirements for direct supervision
21 by physicians for therapeutic hospital outpatient services).
