AN ACT

To name the Department of Veterans Affairs medical center in Waco, Texas, as the "Doris Miller Department of Veterans Affairs Medical Center".

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. FINDINGS.

2	Congress makes the following findings:		
3	(1) On October 12, 1919, Doris Miller was born		
4	in Waco, Texas.		
5	(2) On September 16, 1939, Miller enlisted in		
6	the United States Navy as mess attendant, third		
7	class at Naval Recruiting Station, Dallas, Texas, to		
8	serve for a period of six years.		
9	(3) On February 16, 1941, Miller received a		
10	change of rating to mess attendant, second class.		
11	(4) On June 1, 1942, Miller received a change		
12	of rating to mess attendant, first class.		
13	(5) On June 1, 1943, Miller received a change		
14	of rating, to cook, third class.		
15	(6) On November 25, 1944, Miller was pre-		
16	sumed dead by the Secretary of the Navy a year and		
17	a day after being carried as missing in action since		
18	November 24, 1943, while serving aboard USS		
19	Liscome Bay when that vessel was torpedoed and		
20	sunk in the Pacific Ocean.		
21	(7) Miller was awarded the Navy Cross Medal,		
22	Purple Heart Medal, American Defense Service		
23	Medal, Asiatic-Pacific Campaign Medal, and World		
24	War II Victory Medal.		
25	(8) Miller's citation for the Navy Cross said		
26	"for distinguished devotion to duty, extraordinary		

- 1 courage and disregard for his own personal safety
- during the attack on the Fleet in Pearl Harbor, Ter-
- 3 ritory of Hawaii, by Japanese forces on December 7,
- 4 1941. While at the side of his Captain on the bridge,
- 5 Miller, despite enemy strafing and bombing and in
- 6 the face of a serious fire, assisted in moving his
- 7 Captain, who had been mortally wounded, to a place
- 8 of greater safety, and later manned and operated a
- 9 machine gun directed at enemy Japanese attacking
- aircraft until ordered to leave the bridge.".
- 11 (9) On June 20, 1973, the USS Miller (FF-
- 12 1091), a Knox-class frigate, was named in honor of
- Doris Miller.
- 14 SEC. 2. NAME OF DEPARTMENT OF VETERANS AFFAIRS
- 15 MEDICAL CENTER, WACO, TEXAS.
- 16 The Department of Veterans Affairs medical center
- 17 in Waco, Texas, shall after the date of the enactment of
- 18 this Act be known and designated as the "Doris Miller
- 19 Department of Veterans Affairs Medical Center". Any ref-
- 20 erence to such medical center in any law, regulation, map,
- 21 document, record, or other paper of the United States

- 1 shall be considered to be a reference to the Doris Miller
- 2 Department of Veterans Affairs Medical Center.
