A BILL

To amend the Endangered Species Act of 1973 to require publication on the Internet of the basis for determinations that species are endangered species or threatened species, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “21st Century Endan-*
5 *gered Species Transparency Act”.*

6 **SEC. 2. REQUIREMENT TO PUBLISH ON THE INTERNET THE**
7 **BASIS FOR LISTINGS.**

8 *Section 4(b) of the Endangered Species Act (16 U.S.C.*
9 *1533(b)) is amended by adding at the end the following:*

10 *“(9) The Secretary shall make publicly available on*
11 *the Internet the best scientific and commercial data avail-*
12 *able that are the basis for each regulation, including each*
13 *proposed regulation, promulgated under subsection (a)(1),*
14 *except that, at the request of a Governor or legislature of*
15 *a State, the Secretary shall not make available under this*
16 *paragraph information regarding which the State has de-*
17 *termined public disclosure is prohibited by a law of that*
18 *State relating to the protection of personal information.”.*
