A BILL

To reauthorize programs authorized under the Debbie Smith
Act of 2004, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Debbie Smith Reau-
5 thorization Act of 2014”.

6 **SEC. 2. GENERAL REAUTHORIZATION.**

7 Section 2 of the DNA Analysis Backlog Elimination
8 Act of 2000 (42 U.S.C. 14135) is amended—

9 (1) in subsection (c)(3)—

10 (A) in subparagraph (B), by striking
11 “2010 through 2018” and inserting “2014
12 through 2019”; and

13 (B) in subparagraph (C), by striking
14 “2018” and inserting “2019”; and

15 (2) in subsection (j), by striking “2009 through
16 2014” and inserting “2015 through 2019”.

17 **SEC. 3. TRAINING AND EDUCATION.**

18 Section 303(b) of the DNA Sexual Assault Justice
19 Act of 2004 (42 U.S.C. 14136(b)) is amended by striking
20 “2009 through 2014” and inserting “2015 through
21 2019”.

22 **SEC. 4. SEXUAL ASSAULT FORENSIC EXAM GRANTS.**

23 Section 304(c) of the DNA Sexual Assault Justice
24 Act of 2004 (42 U.S.C. 14136a(c)) is amended by striking

1 “2009 through 2014” and inserting “2015 through
2 2019”.
