Mr. BISHOP of Utah (for himself, Mr. MCCLINTOCK, Mr. CALVERT, Mr. SCHOCK, Mr. HUIZENG of Michigan, Mr. STOCKMAN, and Mr. WEST-MORELAND) introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To enhance the operation of the Dwight D. Eisenhower
Memorial Commission.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Dwight D. Eisenhower
5 Memorial Commission Reform Act”.

6 **SEC. 2. DWIGHT D. EISENHOWER MEMORIAL.**

7 (a) AMENDMENTS.—Section 8162 of Public Law
8 106–79 (40 U.S.C. 8903 note) is amended as follows:

9 (1) In subsection (c)—

1 (A) in paragraph (2) by striking “Members
2 of the Senate” and inserting “persons”; and

3 (B) in paragraph (3), by striking “Mem-
4 bers of the House of Representatives” and in-
5 serting “persons”.

6 (2) By redesignating subsections (f), (g), (h),
7 (i), (j), (k), (l), (m), (n), (o), (p), and (q) as sub-
8 sections (g), (h), (i), (j), (k), (l), (m), (o), (p), (q),
9 (r), and (s), respectively.

10 (3) By inserting after subsection (e) the fol-
11 lowing:

12 “(f) APPOINTMENTS.—Each appointment of a Com-
13 mission member shall be made in consultation with the
14 Eisenhower Foundation, a section 501(c)(3) public foun-
15 dation located in Abilene, Kansas.”.

16 (b) COMMISSION TERMINATION; STAFF; RECORDS.—

17 (1) MEMBERSHIP.—The membership of the
18 Dwight D. Eisenhower Memorial Commission in ex-
19 istence on the date of the enactment of this Act
20 shall terminate on the date of enactment of this Act.
21 New members of the Commission shall be appointed
22 in accordance with section 8162 of Public Law 106–
23 79, this Act, and the amendments made by this Act.

24 (2) STAFF.—The Executive Director and the
25 staff of the Dwight D. Eisenhower Memorial Com-

1 mission in existence on the date of enactment of this
2 Act shall cease to be employed by the Commission
3 on the date that is 30 days after the date of enact-
4 ment of this Act.

5 (3) RECORDS.—Any records of the Commission
6 in existence on the date that the staff is no longer
7 employed by the Commission under paragraph (2)
8 shall be retained by the General Services Adminis-
9 tration or the Secretary of the Interior until such
10 time as a new Dwight D. Eisenhower Memorial
11 Commission is appointed. The records of the former
12 Commission shall be transferred to the newly ap-
13 pointed Commission as soon as possible.
