Mr. WOODALL, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the Senate amendment to the joint resolution (H.J. Res. 59) making continuing appropriations for fiscal year 2014, and for other purposes; providing for consideration of motions to suspend the rules; providing for proceedings during the period from December 14, 2013, through January 6, 2014; and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to take from the Speaker's table the joint
3 resolution (H.J. Res. 59) making continuing appropria-

1 tions for fiscal year 2014, and for other purposes, with
2 the House amendment to the Senate amendment thereto,
3 and to consider in the House, without intervention of any
4 point of order, a motion offered by the chair of the Com-
5 mittee on the Budget or his designee that the House re-
6 cede from its amendment and concur in the Senate
7 amendment with the amendment printed in part A of the
8 report of the Committee on Rules accompanying this reso-
9 lution modified by the amendment printed in part B of
10 that report. The Senate amendment and the motion shall
11 be considered as read. The motion shall be debatable for
12 70 minutes, with 60 minutes equally divided and con-
13 trolled by the chair and ranking minority member of the
14 Committee on the Budget and 10 minutes equally divided
15 and controlled by the chair and ranking minority member
16 of the Committee on Energy and Commerce. The previous
17 question shall be considered as ordered on the motion to
18 its adoption without intervening motion or demand for di-
19 vision of the question.

20 SEC. 2. The chair of the Committee on the Budget
21 may insert in the Congressional Record at any time during
22 the remainder of the first session of the 113th Congress
23 such material as he may deem explanatory of the motion
24 specified in the first section of this resolution.

1 SEC. 3. In the engrossment of the House amendment
2 to the Senate amendment to House Joint Resolution 59,
3 the Clerk may conform division, title, and section numbers
4 and conform cross-references and provisions for short ti-
5 tles.

6 SEC. 4. The chair of the Committee on Armed Serv-
7 ices may insert in the Congressional Record at any time
8 during the remainder of the first session of the 113th Con-
9 gress such material as he may deem explanatory of de-
10 fense authorization measures for the fiscal year 2014.

11 SEC. 5. It shall be in order at any time on the legisla-
12 tive day of December 12, 2013, or December 13, 2013,
13 for the Speaker to entertain motions that the House sus-
14 pend the rules as though under clause 1 of rule XV. The
15 Speaker or his designee shall consult with the Minority
16 Leader or her designee on the designation of any matter
17 for consideration pursuant to this section.

18 SEC. 6. On any legislative day of the first session of
19 the One Hundred Thirteenth Congress after December 13,
20 2013—

21 (a) the Journal of the proceedings of the previous day
22 shall be considered as approved; and

23 (b) the Chair may at any time declare the House ad-
24 journed to meet at a date and time, within the limits of

1 clause 4, section 5, article I of the Constitution, to be an-
2 nounced by the Chair in declaring the adjournment.

3 SEC. 7. On any legislative day of the second session
4 of the One Hundred Thirteenth Congress before January
5 7, 2014—

6 (a) the Speaker may dispense with organizational and
7 legislative business;

8 (b) the Journal of the proceedings of the previous day
9 shall be considered as approved if applicable; and

10 (c) the Chair at any time may declare the House ad-
11 journed to meet at a date and time, within the limits of
12 clause 4, section 5, article I of the Constitution, to be an-
13 nounced by the Chair in declaring the adjournment.

14 SEC. 8. The Speaker may appoint Members to per-
15 form the duties of the Chair for the duration of the period
16 addressed by sections 6 and 7 as though under clause 8(a)
17 of rule I.

18 SEC. 9. Each day during the period addressed by sec-
19 tions 6 and 7 of this resolution shall not constitute a cal-
20 endar day for purposes of section 7 of the War Powers
21 Resolution (50 U.S.C. 1546).

22 SEC. 10. Upon adoption of this resolution it shall be
23 in order to consider in the House the bill (H.R. 3695)
24 to provide a temporary extension of the Food, Conserva-
25 tion, and Energy Act of 2008 and amendments made by

1 that Act, as previously extended and amended and with
2 certain additional modifications and exceptions, to sus-
3 pend permanent price support authorities, and for other
4 purposes. All points of order against consideration of the
5 bill are waived. The amendment printed in part C of the
6 report of the Committee on Rules accompanying this reso-
7 lution shall be considered as adopted. The bill, as amend-
8 ed, shall be considered as read. All points of order against
9 provisions in the bill, as amended, are waived. The pre-
10 vious question shall be considered as ordered on the bill,
11 as amended, and on any amendment thereto to final pas-
12 sage without intervening motion except: (1) 40 minutes
13 of debate equally divided and controlled by the chair and
14 ranking minority member of the Committee on Agri-
15 culture; and (2) one motion to recommit with or without
16 instructions.

17 SEC. 11. The requirement of clause 6(a) of rule XIII
18 for a two-thirds vote to consider a report from the Com-
19 mittee on Rules on the same day it is presented to the
20 House is waived with respect to any resolution reported
21 through the legislative day of December 13, 2013.
