Mr. BURGESS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 2279) to amend the Solid Waste Disposal Act relating to review of regulations under such Act and to amend the Comprehensive Environmental Response, Compensation, and Liability Act of 1980 relating to financial responsibility for classes of facilities; providing for consideration of the bill (H.R. 3362) to amend the Patient Protection and Affordable

Care Act to require transparency in the operation of American Health Benefit Exchanges; and providing for consideration of the bill (H.R. 3811) to require notification of individuals of breaches of personally identifiable information through Exchanges under the Patient Protection and Affordable Care Act.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 2279) to amend the Solid Waste  
6 Disposal Act relating to review of regulations under such  
7 Act and to amend the Comprehensive Environmental Re-  
8 sponse, Compensation, and Liability Act of 1980 relating  
9 to financial responsibility for classes of facilities. The first  
10 reading of the bill shall be dispensed with. All points of  
11 order against consideration of the bill are waived. General  
12 debate shall be confined to the bill and shall not exceed  
13 one hour equally divided and controlled by the chair and  
14 ranking minority member of the Committee on Energy  
15 and Commerce. After general debate the bill shall be con-  
16 sidered for amendment under the five-minute rule. In lieu  
17 of the amendment in the nature of a substitute rec-  
18 ommended by the Committee on Energy and Commerce  
19 now printed in the bill, it shall be in order to consider  
20 as an original bill for the purpose of amendment under

1 the five-minute rule an amendment in the nature of a sub-  
2 stitute consisting of the text of Rules Committee Print  
3 113-30. That amendment in the nature of a substitute  
4 shall be considered as read. All points of order against  
5 that amendment in the nature of a substitute are waived.  
6 No amendment to that amendment in the nature of a sub-  
7 stitute shall be in order except those printed in part A  
8 of the report of the Committee on Rules accompanying  
9 this resolution. Each such amendment may be offered only  
10 in the order printed in the report, may be offered only  
11 by a Member designated in the report, shall be considered  
12 as read, shall be debatable for the time specified in the  
13 report equally divided and controlled by the proponent and  
14 an opponent, shall not be subject to amendment, and shall  
15 not be subject to a demand for division of the question  
16 in the House or in the Committee of the Whole. All points  
17 of order against such amendments are waived. At the con-  
18 clusion of consideration of the bill for amendment the  
19 Committee shall rise and report the bill to the House with  
20 such amendments as may have been adopted. Any Member  
21 may demand a separate vote in the House on any amend-  
22 ment adopted in the Committee of the Whole to the bill  
23 or to the amendment in the nature of a substitute made  
24 in order as original text. The previous question shall be  
25 considered as ordered on the bill and amendments thereto

1 to final passage without intervening motion except one  
2 motion to recommit with or without instructions.

3       SEC. 2. Upon adoption of this resolution it shall be  
4 in order to consider in the House the bill (H.R. 3362)  
5 to amend the Patient Protection and Affordable Care Act  
6 to require transparency in the operation of American  
7 Health Benefit Exchanges. All points of order against con-  
8 sideration of the bill are waived. The amendment printed  
9 in part B of the report of the Committee on Rules accom-  
10 panying this resolution shall be considered as adopted.  
11 The bill, as amended, shall be considered as read. All  
12 points of order against provisions in the bill, as amended,  
13 are waived. The previous question shall be considered as  
14 ordered on the bill, as amended, and on any amendment  
15 thereto to final passage without intervening motion except:  
16 (1) one hour of debate, with 40 minutes equally divided  
17 and controlled by the chair and ranking minority member  
18 of the Committee on Energy and Commerce and 20 min-  
19 utes equally divided and controlled by the chair and rank-  
20 ing minority member of the Committee on Ways and  
21 Means; and (2) one motion to recommit with or without  
22 instructions.

23       SEC. 3. Upon adoption of this resolution it shall be  
24 in order to consider in the House the bill (H.R. 3811)  
25 to require notification of individuals of breaches of person-

1 ally identifiable information through Exchanges under the  
2 Patient Protection and Affordable Care Act. All points of  
3 order against consideration of the bill are waived. The bill  
4 shall be considered as read. All points of order against  
5 provisions in the bill are waived. The previous question  
6 shall be considered as ordered on the bill and on any  
7 amendment thereto to final passage without intervening  
8 motion except: (1) one hour of debate equally divided and  
9 controlled by the chair and ranking minority member of  
10 the Committee on Energy and Commerce; and (2) one mo-  
11 tion to recommit.
