Mr. SESSIONS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 3193) to amend the Consumer Financial Protection Act of 2010 to strengthen the review authority of the Financial Stability Oversight Council of regulations issued by the Bureau of Consumer Financial Protection, and for other purposes; providing for proceedings during the period from February 13, 2014, through February 24, 2014; and for other purposes.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 3193) to amend the Consumer Fi-  
6 nancial Protection Act of 2010 to strengthen the review  
7 authority of the Financial Stability Oversight Council of  
8 regulations issued by the Bureau of Consumer Financial  
9 Protection, and for other purposes. The first reading of  
10 the bill shall be dispensed with. All points of order against  
11 consideration of the bill are waived. General debate shall  
12 be confined to the bill and amendments specified in this  
13 section and shall not exceed one hour equally divided and  
14 controlled by the chair and ranking minority member of  
15 the Committee on Financial Services. After general debate  
16 the bill shall be considered for amendment under the five-  
17 minute rule. It shall be in order to consider as an original  
18 bill for the purpose of amendment under the five-minute  
19 rule an amendment in the nature of a substitute consisting  
20 of the text of Rules Committee Print 113-36 modified by  
21 the amendment printed in part A of the report of the Com-  
22 mittee on Rules accompanying this resolution. That  
23 amendment in the nature of a substitute shall be consid-  
24 ered as read. All points of order against that amendment  
25 in the nature of a substitute are waived. No amendment

1 to that amendment in the nature of a substitute shall be  
2 in order except those printed in part B of the report of  
3 the Committee on Rules accompanying this resolution.  
4 Each such amendment may be offered only in the order  
5 printed in the report, may be offered only by a Member  
6 designated in the report, shall be considered as read, shall  
7 be debatable for the time specified in the report equally  
8 divided and controlled by the proponent and an opponent,  
9 shall not be subject to amendment, and shall not be sub-  
10 ject to a demand for division of the question in the House  
11 or in the Committee of the Whole. All points of order  
12 against such amendments are waived. At the conclusion  
13 of consideration of the bill for amendment the Committee  
14 shall rise and report the bill to the House with such  
15 amendments as may have been adopted. Any Member may  
16 demand a separate vote in the House on any amendment  
17 adopted in the Committee of the Whole to the bill or to  
18 the amendment in the nature of a substitute made in order  
19 as original text. The previous question shall be considered  
20 as ordered on the bill and amendments thereto to final  
21 passage without intervening motion except one motion to  
22 recommit with or without instructions.

23       SEC. 2. On any legislative day during the period from  
24 February 13, 2014, through February 24, 2014—

1 (a) the Journal of the proceedings of the previous day  
2 shall be considered as approved; and

3 (b) the Chair may at any time declare the House ad-  
4 journed to meet at a date and time, within the limits of  
5 clause 4, section 5, article I of the Constitution, to be an-  
6 nounced by the Chair in declaring the adjournment.

7 SEC. 3. The Speaker may appoint Members to per-  
8 form the duties of the Chair for the duration of the period  
9 addressed by section 2 of this resolution as though under  
10 clause 8(a) of rule I.

11 SEC. 4. The requirement of clause 6(a) of rule XIII  
12 for a two-thirds vote to consider a report from the Com-  
13 mittee on Rules on the same day it is presented to the  
14 House is waived with respect to any resolution reported  
15 through the legislative day of February 12, 2014, pro-  
16 viding for consideration or disposition of a measure relat-  
17 ing to the public debt limit.
