## RESOLUTION

Providing for consideration of the bill (H.R. 1874) to amend the Congressional Budget Act of 1974 to provide for macroeconomic analysis of the impact of legislation, providing for consideration of the bill (H.R. 1871) to amend the Balanced Budget and Emergency Deficit Control Act of 1985 to reform the budget baseline, and providing for consideration of the bill (H.R. 1872) to amend the Balanced Budget and Emergency Deficit Control Act

of 1985 to increase transparency in Federal budgeting, and for other purposes.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 1874) to amend the Congressional  
6 Budget Act of 1974 to provide for macroeconomic analysis  
7 of the impact of legislation. The first reading of the bill  
8 shall be dispensed with. All points of order against consid-  
9 eration of the bill are waived. General debate shall be con-  
10 fined to the bill and shall not exceed one hour equally di-  
11 vided and controlled by the chair and ranking minority  
12 member of the Committee on the Budget. After general  
13 debate the bill shall be considered for amendment under  
14 the five-minute rule. The amendments recommended by  
15 the Committee on the Budget now printed in the bill and  
16 the amendment printed in part A of the report of the Com-  
17 mittee on Rules accompanying this resolution shall be con-  
18 sidered as adopted in the House and in the Committee  
19 of the Whole. The bill, as amended, shall be considered  
20 as read. All points of order against provisions in the bill,  
21 as amended, are waived. No further amendment to the bill,  
22 as amended, shall be in order except those printed in part  
23 B of the report of the Committee on Rules. Each further  
24 amendment may be offered only in the order printed in

1 the report, may be offered only by a Member designated  
2 in the report, shall be considered as read, shall be debat-  
3 able for the time specified in the report equally divided  
4 and controlled by the proponent and an opponent, shall  
5 not be subject to amendment, and shall not be subject to  
6 a demand for division of the question in the House or in  
7 the Committee of the Whole. All points of order against  
8 such further amendments are waived. At the conclusion  
9 of consideration of the bill for amendment the Committee  
10 shall rise and report the bill, as amended, to the House  
11 with such further amendments as may have been adopted.  
12 The previous question shall be considered as ordered on  
13 the bill, as amended, and any further amendment thereto  
14 to final passage without intervening motion except one  
15 motion to recommit with or without instructions.

16       SEC. 2. Upon adoption of this resolution it shall be  
17 in order to consider in the House the bill (H.R. 1871)  
18 to amend the Balanced Budget and Emergency Deficit  
19 Control Act of 1985 to reform the budget baseline. All  
20 points of order against consideration of the bill are waived.  
21 The amendment recommended by the Committee on the  
22 Budget now printed in the bill shall be considered as  
23 adopted. The bill, as amended, shall be considered as read.  
24 All points of order against provisions in the bill, as amend-  
25 ed, are waived. The previous question shall be considered

1 as ordered on the bill, as amended, and on any amendment  
2 thereto to final passage without intervening motion except:  
3 (1) one hour of debate equally divided and controlled by  
4 the chair and ranking minority member of the Committee  
5 on the Budget; and (2) one motion to recommit with or  
6 without instructions.

7       SEC. 3. Upon adoption of this resolution it shall be  
8 in order to consider in the House the bill (H.R. 1872)  
9 to amend the Balanced Budget and Emergency Deficit  
10 Control Act of 1985 to increase transparency in Federal  
11 budgeting, and for other purposes. All points of order  
12 against consideration of the bill are waived. The amend-  
13 ment in the nature of a substitute recommended by the  
14 Committee on the Budget now printed in the bill shall be  
15 considered as adopted. The bill, as amended, shall be con-  
16 sidered as read. All points of order against provisions in  
17 the bill, as amended, are waived. The previous question  
18 shall be considered as ordered on the bill, as amended,  
19 and on any amendment thereto to final passage without  
20 intervening motion except: (1) one hour of debate equally  
21 divided and controlled by the chair and ranking minority  
22 member of the Committee on the Budget; and (2) one mo-  
23 tion to recommit with or without instructions.
