Mr. COLE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4486) making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2015, and for other purposes; and providing for consideration of the bill (H.R. 4487) making appropriations for the Legislative Branch for the fiscal year ending September 30, 2015, and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 4486) making appropriations for
6 military construction, the Department of Veterans Affairs,
7 and related agencies for the fiscal year ending September
8 30, 2015, and for other purposes. The first reading of the
9 bill shall be dispensed with. All points of order against
10 consideration of the bill are waived. General debate shall
11 be confined to the bill and shall not exceed one hour equal-
12 ly divided and controlled by the chair and ranking minor-
13 ity member of the Committee on Appropriations. After
14 general debate the bill shall be considered for amendment
15 under the five-minute rule. Points of order against provi-
16 sions in the bill for failure to comply with clause 2 of rule
17 XXI are waived. During consideration of the bill for
18 amendment, the chair of the Committee of the Whole may
19 accord priority in recognition on the basis of whether the
20 Member offering an amendment has caused it to be print-
21 ed in the portion of the Congressional Record designated
22 for that purpose in clause 8 of rule XVIII. Amendments
23 so printed shall be considered as read. When the com-
24 mittee rises and reports the bill back to the House with
25 a recommendation that the bill do pass, the previous ques-

1 tion shall be considered as ordered on the bill and amend-
2 ments thereto to final passage without intervening motion
3 except one motion to recommit with or without instruc-
4 tions.

5 SEC. 2. At any time after adoption of this resolution
6 the Speaker may, pursuant to clause 2(b) of rule XVIII,
7 declare the House resolved into the Committee of the
8 Whole House on the state of the Union for consideration
9 of the bill (H.R. 4487) making appropriations for the Leg-
10 islative Branch for the fiscal year ending September 30,
11 2015, and for other purposes. The first reading of the bill
12 shall be dispensed with. All points of order against consid-
13 eration of the bill are waived. General debate shall be con-
14 fined to the bill and shall not exceed one hour equally di-
15 vided and controlled by the chair and ranking minority
16 member of the Committee on Appropriations. After gen-
17 eral debate the bill shall be considered for amendment
18 under the five-minute rule. The bill shall be considered
19 as read. All points of order against provisions in the bill
20 for failure to comply with clause 2 of rule XXI are waived.
21 No amendment to the bill shall be in order except those
22 printed in the report of the Committee on Rules accom-
23 panying this resolution. Each such amendment may be of-
24 fered only in the order printed in the report, may be of-
25 fered only by a Member designated in the report, shall

1 be considered as read, shall be debatable for the time spec-
2 ified in the report equally divided and controlled by the
3 proponent and an opponent, shall not be subject to amend-
4 ment, and shall not be subject to a demand for division
5 of the question in the House or in the Committee of the
6 Whole. All points of order against such amendments are
7 waived. At the conclusion of consideration of the bill for
8 amendment the Committee shall rise and report the bill
9 to the House with such amendments as may have been
10 adopted. The previous question shall be considered as or-
11 dered on the bill and amendments thereto to final passage
12 without intervening motion except one motion to recommit
13 with or without instructions.

14 SEC. 3. Pending the adoption of a concurrent resolu-
15 tion on the budget for fiscal year 2015, the amounts pro-
16 vided for current law mandatory budget authority and out-
17 lays contained in the statement of the Chair of the Com-
18 mittee on the Budget of the House of Representatives in
19 the Congressional Record dated April 29, 2014, shall be
20 considered for all purposes in the House to be allocations
21 to the Committee on Appropriations under section 302(a)
22 of the Congressional Budget Act of 1974.

23 SEC. 4. During consideration of H.R. 4486 and H.R.
24 4487 pursuant to this resolution, the suballocations print-
25 ed in House Report 113-425 shall be considered for all

- 1 purposes in the House to be suballocations under section
- 2 302(b) of the Congressional Budget Act of 1974.
