RESOLUTION

Providing for consideration of the bill (H.R. 4413) to reauthorize the Commodity Futures Trading Commission, to better protect futures customers, to provide end users with market certainty, to make basic reforms to ensure transparency and accountability at the Commission, to help farmers, ranchers, and end users manage risks to help keep consumer costs low, and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule

1 XVIII, declare the House resolved into the Committee of
2 the Whole House on the state of the Union for consider-
3 ation of the bill (H.R. 4413) to reauthorize the Com-
4 modity Futures Trading Commission, to better protect fu-
5 tures customers, to provide end users with market cer-
6 tainty, to make basic reforms to ensure transparency and
7 accountability at the Commission, to help farmers, ranch-
8 ers, and end users manage risks to help keep consumer
9 costs low, and for other purposes. The first reading of the
10 bill shall be dispensed with. All points of order against
11 consideration of the bill are waived. General debate shall
12 be confined to the bill and amendments specified in this
13 resolution and shall not exceed one hour equally divided
14 and controlled by the chair and ranking minority member
15 of the Committee on Agriculture. After general debate the
16 bill shall be considered for amendment under the five-
17 minute rule. It shall be in order to consider as an original
18 bill for the purpose of amendment under the five-minute
19 rule an amendment in the nature of a substitute consisting
20 of the text of Rules Committee Print 113-47. That amend-
21 ment in the nature of a substitute shall be considered as
22 read. All points of order against that amendment in the
23 nature of a substitute are waived. No amendment to that
24 amendment in the nature of a substitute shall be in order
25 except those printed in the report of the Committee on

1 Rules accompanying this resolution. Each such amend-
2 ment may be offered only in the order printed in the re-
3 port, may be offered only by a Member designated in the
4 report, shall be considered as read, shall be debatable for
5 the time specified in the report equally divided and con-
6 trolled by the proponent and an opponent, shall not be
7 subject to amendment, and shall not be subject to a de-
8 mand for division of the question in the House or in the
9 Committee of the Whole. All points of order against such
10 amendments are waived. At the conclusion of consider-
11 ation of the bill for amendment the Committee shall rise
12 and report the bill to the House with such amendments
13 as may have been adopted. Any Member may demand a
14 separate vote in the House on any amendment adopted
15 in the Committee of the Whole to the bill or to the amend-
16 ment in the nature of a substitute made in order as origi-
17 nal text. The previous question shall be considered as or-
18 dered on the bill and amendments thereto to final passage
19 without intervening motion except one motion to recommit
20 with or without instructions.
