Mr. SESSIONS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for further consideration of the bill (H.R. 5230) making supplemental appropriations for the fiscal year ending September 30, 2014, and for other purposes; providing for consideration of the bill (H.R. 5272) to prohibit certain actions with respect to deferred action for aliens not lawfully present in the United States, and for other purposes; and providing for consideration of motions to suspend the rules.

1 *Resolved*, That during further consideration of the bill
2 (H.R. 5230) making supplemental appropriations for the
3 fiscal year ending September 30, 2014, and for other pur-
4 poses, pursuant to House Resolution 696:

5 (a) the amendments printed in part A of the report
6 of the Committee on Rules accompanying this resolution
7 shall be considered as adopted;

8 (b) all points of order against provisions in the bill,
9 as amended, are waived; and

10 (c) the previous question shall be considered as or-
11 dered on the bill, as amended, and on any further amend-
12 ment thereto to final passage without intervening motion
13 except (1) one additional hour of debate equally divided
14 and controlled by the chair and ranking minority member
15 of the Committee on Appropriations and (2) one motion
16 to recommit with or without instructions.

17 SEC. 2. After passage of H.R. 5230, and on the legis-
18 lative day of August 1, 2014, the House shall consider
19 in the House the bill (H.R. 5272) to prohibit certain ac-
20 tions with respect to deferred action for aliens not lawfully
21 present in the United States, and for other purposes. All
22 points of order against consideration of the bill are waived.
23 The amendment printed in part B of the report of the
24 Committee on Rules accompanying this resolution shall be
25 considered as adopted. The bill, as amended, shall be con-

1 sidered as read. All points of order against provisions in
2 the bill, as amended, are waived. The previous question
3 shall be considered as ordered on the bill, as amended,
4 and on any further amendment thereto to final passage
5 without intervening motion except: (1) one hour of debate
6 equally divided and controlled by the chair and ranking
7 minority member of the Committee on the Judiciary; and
8 (2) one motion to recommit with or without instructions.

9 SEC. 3. Section 2 of House Resolution 700 is amend-
10 ed to read as follows: “Sec. 2. It shall be in order at any
11 time on the legislative day of August 1, 2014, for the
12 Speaker to entertain motions that the House suspend the
13 rules, as though under clause 1 of rule XV, relating to
14 a measure addressing missile defense of Israel.”.
