RESOLUTION

Providing for consideration of the bill (H.R. 2) to remove Federal Government obstacles to the production of more domestic energy; to ensure transport of that energy reliably to businesses, consumers, and other end users; to lower the cost of energy to consumers; to enable manufacturers and other businesses to access domestically produced energy affordably and reliably in order to create

and sustain more secure and well-paying American jobs; and for other purposes; providing for consideration of the bill (H.R. 4) to make revisions to Federal law to improve the conditions necessary for economic growth and job creation, and for other purposes; and providing for proceedings during the period from September 22, 2014, through November 11, 2014.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 2) to remove Federal Government obstacles to the produc-
4 tion of more domestic energy; to ensure transport of that
5 energy reliably to businesses, consumers, and other end
6 users; to lower the cost of energy to consumers; to enable
7 manufacturers and other businesses to access domestically
8 produced energy affordably and reliably in order to create
9 and sustain more secure and well-paying American jobs;
10 and for other purposes. All points of order against consid-
11 eration of the bill are waived. The bill shall be considered
12 as read. All points of order against provisions in the bill
13 are waived. The previous question shall be considered as
14 ordered on the bill and on any amendment thereto to final
15 passage without intervening motion except: (1) two hours
16 of debate equally divided and controlled by the chair and
17 ranking minority member of the Committee on Natural
18 Resources or their respective designees; and (2) one mo-
19 tion to recommit.

1 SEC. 2. Upon adoption of this resolution it shall be
2 in order to consider in the House the bill (H.R. 4) to make
3 revisions to Federal law to improve the conditions nec-
4 essary for economic growth and job creation, and for other
5 purposes. All points of order against consideration of the
6 bill are waived. The bill shall be considered as read. All
7 points of order against provisions in the bill are waived.
8 The previous question shall be considered as ordered on
9 the bill and on any amendment thereto to final passage
10 without intervening motion except: (1) two hours of debate
11 equally divided and controlled by the chair and ranking
12 minority member of the Committee on Ways and Means
13 or their respective designees; and (2) one motion to recom-
14 mit.

15 SEC. 3. On any legislative day during the period from
16 September 22, 2014, through November 11, 2014,—

17 (a) the Journal of the proceedings of the previous day
18 shall be considered as approved; and

19 (b) the Chair may at any time declare the House ad-
20 journed to meet at a date and time, within the limits of
21 clause 4, section 5, article I of the Constitution, to be an-
22 nounced by the Chair in declaring the adjournment.

23 SEC. 4. The Speaker may appoint Members to per-
24 form the duties of the Chair for the duration of the period

1 addressed by section 3 of this resolution as though under
2 clause 8(a) of rule I.

3 SEC. 5. Each day during the period addressed by sec-
4 tion 3 of this resolution shall not constitute a calendar
5 day for purposes of section 7 of the War Powers Resolu-
6 tion (50 U.S.C. 1546).

7 SEC. 6. Each day during the period addressed by sec-
8 tion 3 of this resolution shall not constitute a legislative
9 day for purposes of clause 7 of rule XIII.
