

In the House of Representatives, U. S.,

Resolved, That the bill from the Senate (S. 25) entitled “An Act to direct the Secretary of the Interior to convey certain Federal features of the electric distribution system to the South Utah Valley Electric Service District, and for other purposes.”, do pass with the following

AMENDMENT:

Strike out all after the enacting clause and insert:

1 ***SECTION 1. EXTENSION OF DIRECT SPENDING REDUCTION***

2 ***FOR FISCAL YEAR 2024.***

3 *Paragraph (6)(B) of section 251A of the Balanced*
4 *Budget and Emergency Deficit Control Act of 1985 (2*
5 *U.S.C. 901a) is amended by striking “and for fiscal year*
6 *2023” and by inserting “, for fiscal year 2023, and for fis-*
7 *cal year 2024”.*

1 **SEC. 2. INAPPLICABILITY OF REDUCED ANNUAL ADJUST-**
 2 **MENT OF RETIRED PAY FOR MEMBERS OF**
 3 **THE ARMED FORCES UNDER THE AGE OF 62**
 4 **UNDER THE BIPARTISAN BUDGET ACT OF**
 5 **2013 WHO FIRST BECAME MEMBERS PRIOR TO**
 6 **JANUARY 1, 2014.**

7 (a) *IN GENERAL.*—Section 1401a(b)(4) of title 10,
 8 *United States Code*, as added by section 403(a) of the Bi-
 9 *partisan Budget Act of 2013 (Public Law 113–67)* and
 10 *amended by section 10001 of the Department of Defense Ap-*
 11 *propriations Act, 2014 (Public Law 113–76)*, is amended
 12 *by adding at the end the following new subparagraph:*

13 “(G) *MEMBERS COVERED.*—*This paragraph*
 14 *applies to a member or former member of an*
 15 *armed force who first became a member of a uni-*
 16 *formed service on or after January 1, 2014.”.*

17 (b) *EFFECTIVE DATE.*—*The amendment made by sub-*
 18 *section (a) shall take effect on December 1, 2015, imme-*
 19 *diately after the coming into effect of section 403 of the Bi-*
 20 *partisan Budget Act of 2013 and the amendments made by*
 21 *that section.*

22 **SEC. 3. TRANSITIONAL FUND FOR SUSTAINABLE GROWTH**
 23 **RATE (SGR) REFORM.**

24 *Section 1898 of the Social Security Act (42 U.S.C.*
 25 *1395iii) is amended—*

1 (1) *by amending the heading to read as follows:*

2 “*TRANSITIONAL FUND FOR SUSTAINABLE GROWTH*
3 *RATE (SGR) REFORM*”;

4 (2) *by amending subsection (a) to read as fol-*
5 *lows:*

6 “(a) *ESTABLISHMENT.—The Secretary shall establish*
7 *under this title a Transitional Fund for Sustainable*
8 *Growth Rate (SGR) Reform (in this section referred to as*
9 *the ‘Fund’) which shall be available to the Secretary to pro-*
10 *vide funds to pay for physicians’ services under part B to*
11 *supplement the conversion factor under section 1848(d) for*
12 *2017 if the conversion factor for 2017 is less than conversion*
13 *factor for 2013.*”;

14 (3) *in subsection (b)(1), by striking “during—”*
15 *and all that follows and inserting “during or after*
16 *2017, \$2,300,000,000.”; and*

17 (4) *in subsection (b)(2), by striking “from the*
18 *Federal” and all that follows and inserting “from the*
19 *Federal Supplementary Medical Insurance Trust*
20 *Fund.”.*
