**A BILL**

To amend the Reclamation Wastewater and Groundwater Study and Facilities Act to authorize the Secretary of the Interior to participate in the City of Hermiston, Oregon, water recycling and reuse project, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. PROJECT AUTHORIZATION.**

2 (a) IN GENERAL.—The Reclamation Wastewater and  
 3 Groundwater Study and Facilities Act (Public Law 102–  
 4 575, title XVI; 43 U.S.C. 390h et seq.) is amended by  
 5 inserting after section 1656 the following:

6 **“SEC. 1657. CITY OF HERMISTON, OREGON, WATER RECY-  
 7 CLING AND REUSE PROJECT.**

8 “(a) AUTHORIZATION.—The Secretary, in coopera-  
 9 tion with the City of Hermiston, Oregon, is authorized to  
 10 participate in the design, planning, and construction of  
 11 permanent facilities to reclaim and reuse water in the City  
 12 of Hermiston, Oregon.

13 “(b) COST SHARE.—The Federal share of the costs  
 14 of the project described in subsection (a) shall not exceed  
 15 25 percent of the total cost.

16 “(c) LIMITATION.—The Secretary shall not provide  
 17 funds for the operation and maintenance of the project  
 18 described in subsection (a).”.

19 (b) CLERICAL AMENDMENT.—The table of sections  
 20 in section 2 of the Reclamation Projects Authorization and  
 21 Adjustment Act of 1992 is amended by inserting after the  
 22 item relating to section 1656 the following:

“Sec. 1657. City of Hermiston, Oregon, water recycling and reuse project.”.

1 **SEC. 2. DEAUTHORIZATION OF WILLOW LAKE NATURAL**  
2 **TREATMENT SYSTEM PROJECT, OREGON.**

3 (a) *IN GENERAL.*—Section 1634 of the Reclamation  
4 Projects Authorization and Adjustment Act of 1992 (43  
5 U.S.C. 390h–16) is repealed.

6 (b) *CONFORMING AMENDMENT.*—The table of contents  
7 of title XVI of the Reclamation Projects Authorization and  
8 Adjustment Act of 1992 (Public Law 102–575; 106 Stat.  
9 4602) is amended by striking the item relating to section  
10 1634.
