Mr. REID submitted the following concurrent resolution; which was considered and agreed to

CONCURRENT RESOLUTION

Providing for a conditional adjournment or recess of the Senate and an adjournment of the House of Representatives.

- 1 *Resolved by the Senate (the House of Representatives*
- 2 *concurring), That when the Senate recesses or adjourns*
- 3 *on any day from Thursday, April 10, 2014, through*
- 4 *Thursday, April 24, 2014, on a motion offered pursuant*
- 5 *to this concurrent resolution by its Majority Leader or his*
- 6 *designee, it stand recessed or adjourned until 12:00 noon*
- 7 *on Monday, April 28, 2014, or such other time on that*
- 8 *day as may be specified by its Majority Leader or his des-*
- 9 *ignee in the motion to recess or adjourn, or until the time*
- 10 *of any reassembly pursuant to section 2 of this concurrent*

1 resolution, whichever occurs first; and that when the
2 House adjourns on any legislative day from Thursday,
3 April 10, 2014, through Thursday, April 24, 2014, on a
4 motion offered pursuant to this concurrent resolution by
5 its Majority Leader or his designee, it stand adjourned
6 until 2:00 p.m. on Monday, April 28, 2014, or until the
7 time of any reassembly pursuant to section 3 of this con-
8 current resolution, whichever occurs first.

9 SEC. 2. (a) The Majority Leader of the Senate or his
10 designee, after consultation with the Minority Leader of
11 the Senate, shall notify the Members of the Senate to reas-
12 semble at such place and time he may designate if, in his
13 opinion, the public interest shall warrant it.

14 (b) After reassembling pursuant to subsection (a),
15 when the Senate adjourns on a motion offered pursuant
16 to this subsection by its Majority Leader or his designee,
17 the Senate shall again stand adjourned pursuant to the
18 first section of this concurrent resolution.

19 SEC. 3. (a) The Speaker or his designee, after con-
20 sultation with the Minority Leader of the House, shall no-
21 tify the Members of the House to reassemble at such place
22 and time he may designate if, in his opinion, the public
23 interest shall warrant it.

24 (b) After reassembling pursuant to subsection (a),
25 when the House adjourns on a motion offered pursuant

- 1 to this subsection by its Majority Leader or his designee,
- 2 the House shall again stand adjourned pursuant to the
- 3 first section of this concurrent resolution.
