CONCURRENT RESOLUTION

1 *Resolved by the Senate (the House of Representatives*
2 *concurring)*, That when the Senate recesses or adjourns
3 on any day from Thursday, September 18, 2014, through
4 Tuesday, October 14, 2014, on a motion offered pursuant
5 to this concurrent resolution by its Majority Leader or his
6 designee, it stand recessed or adjourned until 12:00 noon
7 on Wednesday, October 15, 2014, or such other time on
8 that day as may be specified by its Majority Leader or
9 his designee in the motion to recess or adjourn; and that
10 when the Senate recesses or adjourns on Wednesday, Oc-
11 tober 15, 2014, it stand adjourned until 12:00 noon on
12 Wednesday, November 12, 2014, or such other time on
13 that day as may be specified by its Majority Leader or
14 his designee, or until the time of any reassembly pursuant
15 to section 2 of this concurrent resolution, whichever occurs
16 first; and that when the House adjourns on any legislative
17 day from Thursday, September 18, 2014, through Friday,
18 November 7, 2014, on a motion offered pursuant to this
19 concurrent resolution by its Majority Leader or his des-

1 ignee, it stand adjourned until 2:00 p.m. on Wednesday,
2 November 12, 2014, or until the time of any reassembly
3 pursuant to section 3 of this concurrent resolution, which-
4 ever occurs first.

5 SEC. 2. (a) The Majority Leader of the Senate or his
6 designee, after concurrence with the Minority Leader of
7 the Senate, shall notify the Members of the Senate to reas-
8 semble at such place and time as he may designate if, in
9 his opinion, the public interest shall warrant it.

10 (b) After reassembling pursuant to subsection (a),
11 when the Senate adjourns on a motion offered pursuant
12 to this subsection by its Majority Leader or his designee,
13 the Senate shall again stand adjourned pursuant to the
14 first section of this concurrent resolution.

15 SEC. 3. (a) The Speaker or his designee, after con-
16 sultation with the Minority Leader of the House, shall no-
17 tify the Members of the House to reassemble at such place
18 and time as he may designate if, in his opinion, the public
19 interest shall warrant it.

20 (b) After reassembling pursuant to subsection (a),
21 when the House adjourns on a motion offered pursuant
22 to this subsection by its Majority Leader or his designee,

- 1 the House shall again stand adjourned pursuant to the
- 2 first section of this concurrent resolution.
