## SURROUNDING VISIT OF HIS HOLINESS POPE FRANCIS TO UNITED STATES CAPITOL.

The rotunda of the United States Capitol is authorized to be used for ceremonies and activities surrounding the visit of His Holiness Pope Francis to the United States Capitol on September 24, 2015, or on such other dates as the Speaker of the House of Representatives and the Committee on Rules and Administration of the Senate may jointly designate. Physical preparations for the con duct of such ceremonies and activities shall be carried out
 in accordance with such conditions as the Architect of the
 Capitol may prescribe.

## 5 SEC. 3. AUTHORIZATION OF USE OF EMANCIPATION HALL 6 FOR EVENTS SURROUNDING VISIT OF HIS 7 HOLINESS POPE FRANCIS TO UNITED STATES 8 CAPITOL.

9 Emancipation Hall in the Capitol Visitor Center is 10 authorized to be used for ceremonies and activities surrounding the visit of His Holiness Pope Francis to the 11 United States Capitol on September 24, 2015, or on such 12 13 other dates as the Speaker of the House of Representatives and the Committee on Rules and Administration of 14 15 the Senate may jointly designate. Physical preparations 16 for the conduct of such ceremonies and activities shall be 17 carried out in accordance with such conditions as the Ar-18 chitect of the Capitol may prescribe.
