1 **SEC. 2. AUTHORIZATION OF USE OF ROTUNDA FOR EVENTS**  
2 **SURROUNDING VISIT OF HIS HOLINESS POPE**  
3 **FRANCIS TO UNITED STATES CAPITOL.**

4 The rotunda of the United States Capitol is author-  
5 ized to be used for ceremonies and activities surrounding  
6 the visit of His Holiness Pope Francis to the United  
7 States Capitol on September 24, 2015, or on such other  
8 dates as the Speaker of the House of Representatives and  
9 the Committee on Rules and Administration of the Senate  
10 may jointly designate. Physical preparations for the con-  
11 duct of such ceremonies and activities shall be carried out  
12 in accordance with such conditions as the Architect of the  
13 Capitol may prescribe.

14 **SEC. 3. AUTHORIZATION OF USE OF EMANCIPATION HALL**  
15 **FOR EVENTS SURROUNDING VISIT OF HIS**  
16 **HOLINESS POPE FRANCIS TO UNITED STATES**  
17 **CAPITOL.**

18 Emancipation Hall in the Capitol Visitor Center is  
19 authorized to be used for ceremonies and activities sur-  
20 rounding the visit of His Holiness Pope Francis to the  
21 United States Capitol on September 24, 2015, or on such  
22 other dates as the Speaker of the House of Representa-  
23 tives and the Committee on Rules and Administration of  
24 the Senate may jointly designate. Physical preparations  
25 for the conduct of such ceremonies and activities shall be

1 carried out in accordance with such conditions as the Ar-  
2 chitect of the Capitol may prescribe.

3 **SEC. 4. ARRANGEMENTS WITH OTHER DEPARTMENTS AND**  
4 **AGENCIES.**

5 In carrying out their duties under this concurrent  
6 resolution, the Architect of the Capitol and the Capitol  
7 Police Board are each authorized to utilize appropriate  
8 equipment and services of appropriate personnel of depart-  
9 ments and agencies of the Federal Government, under  
10 such arrangements as each may enter into with the heads  
11 of those departments and agencies in connection with the  
12 ceremonies and activities surrounding the visit of His Ho-  
13 liness Pope Francis to the United States Capitol.
