JOINT RESOLUTION

Relating to the disapproval of the proposed foreign military sale to the Government of the Kingdom of Saudi Arabia of M1A1/A2 Abrams Tank structures and other major defense equipment.

1 *Resolved by the Senate and House of Representatives*
2 *of the United States of America in Congress assembled,*
3 That the issuance of a letter of offer with respect to any
4 of the following proposed sales to the Government of the
5 Kingdom of Saudi Arabia (described in the certification
6 Transmittal No. 16–32, sent to the Speaker of the House
7 of Representatives and the chairman of the Committee on
8 Foreign Relations of the Senate pursuant to section

1 36(b)(1) of the Arms Export Control Act (22 U.S.C.
2 2776(b)(1))) on August 8, 2016, is hereby prohibited:

3 (1) The proposed sale of one hundred fifty-
4 three (153) M1A1/A2 Abrams Tank structures for
5 conversion to one hundred thirty-three (133) M1A2S
6 Saudi Abrams configured Main Battle Tanks and
7 twenty (20) battle damage replacements for the ex-
8 isting fleet (Transmittal Numbered 16–32).

9 (2) The proposed sale of one hundred fifty-
10 three (153) M2 .50 Caliber Machine Guns (Trans-
11 mittal Numbered 16–32).

12 (3) The proposed sale of two hundred sixty-six
13 (266) 7.62mm M240 Machine Guns (Transmittal
14 Numbered 16–32).

15 (4) The proposed sale of one hundred fifty-
16 three (153) M250 Smoke Grenade Launchers
17 (Transmittal Numbered 16–32).

18 (5) The proposed sale of twenty (20) M88A1/
19 A2 Heavy Equipment Recovery Combat Utility Lift
20 Evacuation System (HERCULES) Armored Recov-
21 ery Vehicle (ARV) Structures for conversion to
22 twenty (20) M88A1/A2 HERCULES ARVs (Trans-
23 mittal Numbered 16–32).

1 (6) The proposed sale of one hundred sixty-nine
2 (169) AN/VAS-5 Driver Vision Enhancer-Abrams
3 (DVE-A) (Transmittal Numbered 16-32).

4 (7) The proposed sale of one hundred thirty-
5 three (133) AN/PVS-7B Night Vision Devices
6 (Transmittal Numbered 16-32).

7 (8) The proposed sale of four thousand two
8 hundred fifty-six (4,256) Rounds M865 Training
9 Ammunition (Transmittal Numbered 16-32).

10 (9) The proposed sale of two thousand three
11 hundred ninety-four (2,394) Rounds M831A1 Train-
12 ing Ammunition (Transmittal Numbered 16-32).
