3	"(1) In general.—Support for a prize com-
4	petition under this section, including financial sup-
5	port for the design and administration of a prize
6	competition or funds for a cash prize purse, may
7	consist of Federal appropriated funds and funds
8	provided by private sector for-profit and nonprofit
9	entities. The head of an agency may accept funds
10	from other Federal agencies, private sector for-profit
11	entities, and nonprofit entities, to be available to the
12	extent provided by appropriations Acts, to support
13	such prize competitions. The head of an agency may
14	not give any special consideration to any private sec-
15	tor for-profit or nonprofit entity in return for a do-
16	nation.";

10	(10) in subsection (o)(1), by striking "or pro					
11	viding a prize" and insert "a prize competition or					
12	providing a cash prize purse"; and					
13	(11) in subsection $(p)(2)$ —					
14	(A) in subparagraph (C), by striking "cash					
15	prizes" both places it occurs and inserting					
16	"cash prize purses"; and					
17	(B) by adding at the end the following new					
18	subparagraph:					
19	"(G) Plan.—A description of crosscutting					
20	topical areas and agency-specific mission needs					
21	that may be the strongest opportunities for
