# A BILL

To make technical changes to provisions authorizing prize competitions under the Stevenson-Wydler Technology Innovation Act of 1980.

1       *Be it enacted by the Senate and House of Representa-*  
2   *tives of the United States of America in Congress assembled,*

3   **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Science Prize Competi-*  
5   *tions Act”.*

6   **SEC. 2. AMENDMENTS TO PRIZE COMPETITIONS.**

7       *Section 24 of the Stevenson-Wydler Technology Inno-*  
8   *vation Act of 1980 (15 U.S.C. 3719) is amended—*

9           (1) in subsection (c)—

10              (A) by inserting “competition” after “sec-

11              tion, a prize”;

12              (B) by inserting “types” after “following”;

13              and

14              (C) in paragraph (4), by striking “prizes”

15              and inserting “prize competitions”;

16           (2) in subsection (f)—

17              (A) by striking “in the Federal Register”

18              and inserting “on a publicly accessible Govern-

19              ment website, such as [www.challenge.gov](http://www.challenge.gov);”; and

20              (B) in paragraph (4), by striking “prize”

21              and inserting “cash prize purse”;

22           (3) in subsection (g), by striking “prize” and in-

23              serting “cash prize purse”;

24           (4) in subsection (h), by inserting “prize” before

25              “competition” both places it appears;

1                   (5) in subsection (i)—

2                   (A) in paragraph (1)(B), by inserting  
3                   “prize” before “competition”;

4                   (B) in paragraph (2)(A), by inserting  
5                   “prize” before “competition” both places it ap-  
6                   pears;

7                   (C) by redesignating paragraph (3) as  
8                   paragraph (4); and

9                   (D) by inserting after paragraph (2) the fol-  
10                  lowing new paragraph:

11                  “(3) WAIVER.—An agency may waive the re-  
12                  quirement under paragraph (2). The annual report  
13                  under subsection (p) shall include a list of such waiv-  
14                  ers granted during the preceding fiscal year, along  
15                  with a detailed explanation of the reasons for grant-  
16                  ing the waivers.”;

17                  (6) in subsection (k)—

18                  (A) in paragraph (2)(A), by inserting  
19                  “prize” before “competition”; and

20                  (B) in paragraph (3), by inserting “prize”  
21                  before “competitions” both places it appears;

22                  (7) in subsection (l), by striking all after “may  
23                  enter into” and inserting “a grant, contract, coopera-  
24                  tive agreement, or other agreement with a private sec-  
25                  tor for-profit or nonprofit entity to administer the

1       *prize competition, subject to the provisions of this sec-*  
2       *tion.”;*

3           *(8) in subsection (m)—*

4              *(A) by amending paragraph (1) to read as*  
5              *follows:*

6              *“(1) IN GENERAL.—Support for a prize competi-*  
7       *tion under this section, including financial support*  
8       *for the design and administration of a prize competi-*  
9       *tion or funds for a cash prize purse, may consist of*  
10      *Federal appropriated funds and funds provided by*  
11      *private sector for-profit and nonprofit entities. The*  
12      *head of an agency may accept funds from other Fed-*  
13      *eral agencies, private sector for-profit entities, and*  
14      *nonprofit entities to support such prize competitions.*  
15      *The head of an agency may not give any special con-*  
16      *sideration to any private sector for-profit or nonprofit*  
17      *entity in return for a donation.”;*

18           *(B) in paragraph (2), by striking “prize*  
19       *awards” and inserting “cash prize purses”;*

20           *(C) in paragraph (3)(A)—*

21              *(i) by striking “No prize” and insert-*  
22       *ing “No prize competition”; and*

23              *(ii) by striking “the prize” and insert-*  
24       *ing “the cash prize purse”;*

1                             (D) in paragraph (3)(B), by striking “a  
2                             prize” and inserting “a cash prize purse”;  
3                             (E) in paragraph (3)(B)(i), by inserting  
4                             “competition” after “prize”;  
5                             (F) in paragraph (4)(A), by striking “a  
6                             prize” and inserting “a cash prize purse”; and  
7                             (G) in paragraph (4)(B), by striking “cash  
8                             prizes” and inserting “cash prize purses”;  
9                             (9) in subsection (n), by inserting “for both for-  
10                             profit and nonprofit entities,” after “contract vehi-  
11                             cle”;  
12                             (10) in subsection (o)(1), by striking “or pro-  
13                             viding a prize” and insert “a prize competition or  
14                             providing a cash prize purse”; and  
15                             (11) in subsection (p)(2)—  
16                                 (A) in subparagraph (C), by striking “cash  
17                             prizes” both places it occurs and inserting “cash  
18                             prize purses”; and  
19                                 (B) by adding at the end the following new  
20                             subparagraph:  
21                                 “(G) PLAN.—A description of crosscutting  
22                             topical areas and agency-specific mission needs  
23                             that may be the strongest opportunities for prize  
24                             competitions during the upcoming 2 fiscal  
25                             years.”.
