A BILL

To amend the Public Health Service Act to provide for
the designation of maternity care health professional
shortage areas.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Improving Access to Ma-*
5 *ternity Care Act”.*

6 **SEC. 2. MATERNITY CARE HEALTH PROFESSIONAL TARGET**
7 **AREAS.**

8 *Section 332 of the Public Health Service Act (42*
9 *U.S.C. 254e) is amended by adding at the end the following*
10 *new subsection:*

11 *“(k)(1) The Secretary, acting through the Adminis-*
12 *trator of the Health Resources and Services Administration,*
13 *shall identify, based on the data collected under paragraph*
14 *(3), maternity care health professional target areas that sat-*
15 *isfy the criteria described in paragraph (2) for purposes*
16 *of, in connection with receipt of assistance under this title,*
17 *assigning to such identified areas maternity care health*
18 *professionals who, without application of this subsection,*
19 *would otherwise be eligible for such assistance. The Sec-*
20 *retary shall distribute maternity care health professionals*
21 *within health professional shortage areas using the mater-*
22 *nity care health professional target areas so identified.*

23 *“(2) For purposes of paragraph (1), the Secretary shall*
24 *establish criteria for maternity care health professional tar-*
25 *get areas that identify geographic areas within health pro-*

1 *professional shortage areas that have a shortage of maternity*
2 *care health professionals.*

3 “(3) *For purposes of this subsection, the Secretary*
4 *shall collect and publish in the Federal Register data com-*
5 *paring the availability and need of maternity care health*
6 *services in health professional shortage areas and in areas*
7 *within such health professional shortage areas.*

8 “(4) *In carrying out paragraph (1), the Secretary*
9 *shall seek input from relevant provider organizations, in-*
10 *cluding medical societies, organizations representing med-*
11 *ical facilities, and other organizations with expertise in ma-*
12 *ternity care.*

13 “(5) *For purposes of this subsection, the term ‘full*
14 *scope maternity care health services’ includes during labor*
15 *care, birthing, prenatal care, and postpartum care.*

16 “(6) *Nothing in this subsection shall be construed as—*
17 “(A) *requiring the identification of a maternity*
18 *care health professional target area in an area not*
19 *otherwise already designated as a health professional*
20 *shortage area; or*

21 “(B) *affecting the types of health professionals,*
22 *without application of this subsection, otherwise eligi-*
23 *ble for assistance, including a loan repayment or*
24 *scholarship, pursuant to the application of this sec-*
25 *tion.’”.*

Amend the title so as to read: “A bill to amend the Public Health Service Act to distribute maternity care health professionals to health professional shortage areas identified as in need of maternity care health services.”.
