A BILL

To authorize the Secretary of the Interior to convey certain land and appurtenances of the Arbuckle Project, Oklahoma, to the Arbuckle Master Conservancy District, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Arbuckle Project Mainte-*
5 *nance Complex and District Office Conveyance Act of*
6 *2016”.*

7 **SEC. 2. CONVEYANCE OF MAINTENANCE COMPLEX AND DIS-**
8 **TRICT OFFICE OF THE ARBUCKLE PROJECT,**
9 **OKLAHOMA.**

10 *(a) IN GENERAL.—The Secretary of the Interior shall,*
11 *as soon as practicable, convey to the Arbuckle Master Con-*
12 *servancy District, located in Murray County, Oklahoma, all*
13 *right, title, and interest of the United States in and to the*
14 *Maintenance Complex and District Office, Arbuckle Project,*
15 *Oklahoma, consistent with the terms and conditions set*
16 *forth in the Agreement between the United States and the*
17 *Arbuckle Master Conservancy District.*

18 *(b) DEFINITIONS.—*

19 *(1) AGREEMENT.—The term “Agreement” means*
20 *the Agreement between the United States and the Ar-*
21 *buckle Master Conservancy District for Transferring*
22 *Title to the Federally Owned Maintenance Complex*
23 *and District Office to the Arbuckle Master Conser-*
24 *vancy District (Agreement No. 14AG640141).*

1 (2) *DISTRICT OFFICE.*—*The term “District Of-*
2 *ice” means the headquarters building located at 2440*
3 *East Main, Davis, Oklahoma, and the approximately*
4 *0.83 acres described in the Agreement.*

5 (3) *MAINTENANCE COMPLEX.*—*The term “Main-*
6 *tenance Complex” means the caretakers residence,*
7 *shop buildings, and any appurtenances located on the*
8 *lands described in the Agreement, to include approxi-*
9 *mately 2.00 acres, more or less.*

10 (c) *LIABILITY.*—*Effective upon the date of conveyance*
11 *of the Maintenance Complex and District Office under this*
12 *section, the United States shall not be held liable by any*
13 *court for damages of any kind arising out of any act, omis-*
14 *sion, or occurrence relating to the Maintenance Complex*
15 *and District Office, except for damages caused by acts of*
16 *negligence committed by the United States or by its employ-*
17 *ees or agents prior to the date of conveyance. Nothing in*
18 *this section increases the liability of the United States be-*
19 *yond that provided in chapter 171 of title 28, United States*
20 *Code (popularly known as the “Federal Tort Claims Act”)*
21 *on the date of the enactment of this Act.*

22 (d) *BENEFITS.*—*After conveyance of the Maintenance*
23 *Complex and District Office to the Arbuckle Master Conser-*
24 *vancy District—*

1 (1) *the Maintenance Complex and District Office*
2 *shall not be considered to be a part of a Federal rec-*
3 *lamation project; and*

4 (2) *such water district shall not be eligible to re-*
5 *ceive any benefits with respect to any facility com-*
6 *prising that Maintenance Complex and District Of-*
7 *fice, except benefits that would be available to a simi-*
8 *larly situated person with respect to such a facility*
9 *that is not part of a Federal reclamation project.*

10 (e) *COMMUNICATION.—If the Secretary of the Interior*
11 *has not completed the conveyance required under subsection*
12 *(a) within 12 months after the date of enactment of this*
13 *Act, the Secretary shall submit to Congress a letter with*
14 *sufficient detail that explains the reasons the conveyance*
15 *has not been completed and stating the date by which the*
16 *conveyance will be completed.*
