A BILL

To authorize the Secretary of the Interior to acquire approximately 44 acres of land in Martinez, California, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “John Muir National*
5 *Historic Site Expansion Act”.*

6 **SEC. 2. JOHN MUIR NATIONAL HISTORIC SITE LAND ACQUI-**
7 **SITION.**

8 (a) *ACQUISITION.*—*The Secretary of the Interior may*
9 *acquire by donation the approximately 44 acres of land,*
10 *and interests in such land, that are identified on the map*
11 *entitled “John Muir National Historic Site Proposed*
12 *Boundary Expansion”, numbered 426/127150, and dated*
13 *November, 2014.*

14 (b) *BOUNDARY.*—*Upon the acquisition of the land au-*
15 *thorized by subsection (a), the Secretary of the Interior shall*
16 *adjust the boundaries of the John Muir Historic Site in*
17 *Martinez, California, to include the land identified on the*
18 *map referred to in subsection (a).*

19 (c) *ADMINISTRATION.*—*The land and interests in land*
20 *acquired under subsection (a) shall be administered as part*
21 *of the John Muir National Historic Site established by the*
22 *Act of August 31, 1964 (Public Law 88–547; 78 Stat. 753;*
23 *16 U.S.C. 461 note).*
