## A BILL

To provide that there shall be no net increase in the acres of certain Federal land under the jurisdiction of the Bureau of Land Management, the National Park Service, the United States Fish and Wildlife Service, or the Forest Service unless the Federal budget is balanced for the year in which the land would be purchased.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Land Acquisition to  
3 cut National Debt Act” or the “LAND Act”.

4 **SEC. 2. DEPARTMENT OF THE INTERIOR LAND ACQUISITION.**  
5 **TION.**

6 (a) IN GENERAL.—The Secretary of the Interior may  
7 not use Federal funds to purchase land that would result  
8 in a net increase of land acreage that would be under the  
9 jurisdiction of the National Park Service, the United  
10 States Fish and Wildlife Service, or the Bureau of Land  
11 Management unless the Federal budget is balanced for the  
12 year in which the land would be purchased.

13 (b) DUCK STAMP FUNDS.—Subsection (a) shall not  
14 apply to land purchased with funds made available  
15 through the sale of Federal Migratory Bird Hunting and  
16 Conservation Stamps.

17 (c) EASEMENTS.—Subsection (a) shall not apply to  
18 easements acquired by the Secretary of the Interior to fa-  
19 cilitate management of Federal lands.

20 **SEC. 3. NATIONAL FOREST SYSTEM LAND ACQUISITION.**

21 (a) IN GENERAL.—The Secretary of Agriculture may  
22 not use Federal funds to purchase land that would result  
23 in a net increase of land acreage included in the National  
24 Forest System unless the Federal budget is balanced for  
25 the year in which the land would be purchased.

1           (b) EASEMENTS.—Subsection (a) shall not apply to  
2 easements acquired by the Secretary of Agriculture to fa-  
3 cilitate management of Federal lands.
