In the Senate of the United States,

Resolved, That the bill from the House of Representatives (H.R. 1475) entitled "An Act to authorize a Wall of Remembrance as part of the Korean War Veterans Memorial and to allow certain private contributions to fund that Wall of Remembrance.", do pass with the following

AMENDMENT:

Strike out all after the enacting clause and insert:

- 1 SECTION 1. SHORT TITLE.
- 2 This Act may be cited as the "Korean War Veterans
- 3 Memorial Wall of Remembrance Act".
- 4 SEC. 2. WALL OF REMEMBRANCE.
- 5 (a) AUTHORIZATION.—
- 6 (1) In General.—Notwithstanding section
- 7 8908(c) of title 40, United States Code, the Korean
- 8 War Veterans Memorial Foundation, Inc., may con-
- 9 struct a Wall of Remembrance at the site of the Ko-
- 10 rean War Veterans Memorial.

1	(2) Requirement.—
2	(A) In General.—The Wall of Remem-
3	brance shall include a list of names of members
4	of the Armed Forces of the United States who
5	died in the Korean War, as determined by the
6	Secretary of Defense, in accordance with sub-
7	paragraph (B).
8	(B) Criteria; submission to the sec-
9	RETARY OF THE INTERIOR.—The Secretary of
10	Defense shall—
11	(i) establish eligibility criteria for the
12	inclusion of names on the Wall of Remem-
13	brance under subparagraph (A); and
14	(ii) provide to the Secretary of the In-
15	terior a final list of names for inclusion on
16	the Wall of Remembrance under subpara-
17	graph (A) that meet the criteria established
18	under clause (i).
19	(3) Additional information.—The Wall of Re-
20	membrance may include other information about the
21	Korean War, including the number of members of the
22	Armed Forces of the United States, the Korean Aug-
23	mentation to the United States Army, the Republic of
24	Korea Armed Forces, and the other nations of the

1	United Nations Command who, in regards to the Ko-
2	rean War—
3	(A) were killed in action;
4	(B) were wounded in action;
5	(C) are listed as missing in action; or
6	(D) were prisoners of war.
7	(b) Commemorative Works Act.—Except as pro-
8	vided in subsection (a)(1), chapter 89 of title 40, United
9	States Code (commonly known as the "Commemorative
10	Works Act"), shall apply.
11	(c) No Federal Funds.—No Federal funds may be
12	used to construct the Wall of Remembrance.
