**AN ACT**

To authorize a Wall of Remembrance as part of the Korean War Veterans Memorial and to allow certain private contributions to fund that Wall of Remembrance.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “~~Korean War Veterans~~  
5 ~~Memorial Wall of Remembrance Act of 2016~~”.

1 **SEC. 2. WALL OF REMEMBRANCE.**

2 Section 1 of the Act titled “An Act to authorize the  
3 erection of a memorial on Federal Land in the District  
4 of Columbia and its environs to honor members of the  
5 Armed Forces of the United States who served in the Ko-  
6 rean War”, approved October 25, 1986 (Public Law 99-  
7 572), is amended by adding at the end the following:

8 “Such memorial shall include a Wall of Remembrance,  
9 which shall be constructed without the use of Federal  
10 funds. The American Battle Monuments Commission shall  
11 request and consider design recommendations from the  
12 Korean War Veterans Memorial Foundation, Inc. for the  
13 establishment of the Wall of Remembrance. The Wall of  
14 Remembrance shall include—

15 “(1) a list by name of members of the Armed  
16 Forces of the United States who died in theatre in  
17 the Korean War;

18 “(2) the number of members of the Armed  
19 Forces of the United States who, in regards to the  
20 Korean War—

21 “(A) were wounded in action;

22 “(B) are listed as missing in action; or

23 “(C) were prisoners of war; and

24 “(3) the number of members of the Korean  
25 Augmentation to the United States Army, the Re-  
26 public of Korea Armed Forces, and the other na-

1        tions of the United Nations Command who, in re-  
2        gards to the Korean War—

3                “(A) were killed in action;

4                “(B) were wounded in action;

5                “(C) are listed as missing in action; or

6                “(D) were prisoners of war.”.

7        **SECTION 1. SHORT TITLE.**

8                *This Act may be cited as the “Korean War Veterans*  
9        *Memorial Wall of Remembrance Act”.*

10        **SEC. 2. WALL OF REMEMBRANCE.**

11                (a) *AUTHORIZATION.—*

12                        (1) *IN GENERAL.—Notwithstanding section*  
13        *8908(c) of title 40, United States Code, the Korean*  
14        *War Veterans Memorial Foundation, Inc., may con-*  
15        *struct a Wall of Remembrance at the site of the Ko-*  
16        *rean War Veterans Memorial.*

17                        (2) *REQUIREMENT.—*

18                                (A) *IN GENERAL.—The Wall of Remem-*  
19        *brance shall include a list of names of members*  
20        *of the Armed Forces of the United States who*  
21        *died in the Korean War, as determined by the*  
22        *Secretary of Defense, in accordance with sub-*  
23        *paragraph (B).*

1           (B) *CRITERIA; SUBMISSION TO THE SEC-*  
2           *RETARY OF THE INTERIOR.—The Secretary of*  
3           *Defense shall—*

4                   (i) *establish eligibility criteria for the*  
5                   *inclusion of names on the Wall of Remem-*  
6                   *brance under subparagraph (A); and*

7                   (ii) *provide to the Secretary of the In-*  
8                   *terior a final list of names for inclusion on*  
9                   *the Wall of Remembrance under subpara-*  
10                  *graph (A) that meet the criteria established*  
11                  *under clause (i).*

12           (3) *ADDITIONAL INFORMATION.—The Wall of Re-*  
13           *membrance may include other information about the*  
14           *Korean War, including the number of members of the*  
15           *Armed Forces of the United States, the Korean Aug-*  
16           *mentation to the United States Army, the Republic of*  
17           *Korea Armed Forces, and the other nations of the*  
18           *United Nations Command who, in regards to the Ko-*  
19           *rean War—*

20                   (A) *were killed in action;*

21                   (B) *were wounded in action;*

22                   (C) *are listed as missing in action; or*

23                   (D) *were prisoners of war.*

24           (b) *COMMEMORATIVE WORKS ACT.—Except as pro-*  
25           *vided in subsection (a)(1), chapter 89 of title 40, United*

1 *States Code (commonly known as the “Commemorative*  
2 *Works Act”), shall apply.*

3       *(c) NO FEDERAL FUNDS.—No Federal funds may be*  
4 *used to construct the Wall of Remembrance.*
