Mr. HUNTER (for himself, Mr. ISRAEL, Mr. COFFMAN, and Mr. JOYCE) introduced the following bill; which was referred to the Committee on Veterans' Affairs

A BILL

To amend title 38, United States Code, to direct the Secretary of Veterans Affairs to increase certain veteran funeral benefits.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. INCREASE TO CERTAIN FUNERAL BENEFITS**

4 **UNDER LAWS ADMINISTERED BY THE SEC-**
5 **RETARY OF VETERANS AFFAIRS.**

6 (a) FUNERAL EXPENSES.—Section 2302(a) of title
7 38, United States Code, is amended—

1 (1) by striking “\$300” and inserting “\$2,000
2 (as increased from time to time under subsection
3 (c))”; and

4 (2) by adding at the end the following new sub-
5 section:

6 “(c) With respect to any fiscal year, the Secretary
7 shall provide a percentage increase (rounded to the near-
8 est dollar) in the maximum amount of burial and funeral
9 expenses payable under subsection (a) equal to the per-
10 centage by which—

11 “(1) the Consumer Price Index (all items,
12 United States city average) for the 12-month period
13 ending on the June 30 preceding the beginning of
14 the fiscal year for which the increase is made, ex-
15 ceeds

16 “(2) the Consumer Price Index for the 12-
17 month period preceding the 12-month period de-
18 scribed in paragraph (1).”.

19 (b) DEATH IN DEPARTMENT FACILITY; PLOT AL-
20 LOWANCE.—Section 2303 of such title is amended by
21 striking “\$700” each place it appears and inserting
22 “\$2,000”.

23 (c) DEATH FROM SERVICE-CONNECTED DIS-
24 ABILITY.—Section 2307 of such title is amended—

1 (1) by inserting striking “In any case” and in-
2 serting the following:

3 “(a) IN GENERAL.—In any case”.

4 (2) by striking “\$2,000” and inserting “\$2,000
5 (as increased from time to time under subsection
6 (b))”; and

7 (3) by adding at the end the following new sub-
8 section:

9 “(b) With respect to any fiscal year, the Secretary
10 shall provide a percentage increase (rounded to the near-
11 est dollar) in the maximum amount of burial and funeral
12 expenses payable under subsection (a) equal to the per-
13 centage by which—

14 “(1) the Consumer Price Index (all items,
15 United States city average) for the 12-month period
16 ending on the June 30 preceding the beginning of
17 the fiscal year for which the increase is made, ex-
18 ceeds

19 “(2) the Consumer Price Index for the 12-
20 month period preceding the 12-month period de-
21 scribed in paragraph (1).”.

22 (d) EFFECTIVE DATE.—The amendments made by
23 this Act shall apply to deaths that occur after the date
24 of the enactment of this Act.
