# **A BILL**

To authorize the Secretary of the Interior to acquire certain property related to the Fort Scott National Historic Site in Fort Scott, Kansas.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AUTHORIZATION TO ACQUIRE LUNETTE BLAIR.**

4 *The Act entitled “An Act to authorize establishment*  
5 *of the Fort Scott National Historic Site, Kansas, and for*  
6 *other purposes.”, approved October 19, 1978 (Public Law*  
7 *95–484) is amended—*

8 *(1) in the first section, by striking “: Provided,*  
9 *that the buildings so acquired shall not include the*  
10 *structure known as ‘Lunette Blair’”; and*

11 *(2) in section 2—*

12 *(A) by striking “SEC. 2. When” and insert-*  
13 *ing the following:*

14 **“SEC. 2. ESTABLISHMENT.**

15 *“(a) IN GENERAL.—When”; and*

16 *(B) by adding at the end the following:*

17 *“(b) BOUNDARY MODIFICATION.—The boundary of the*  
18 *Fort Scott National Historic Site established under sub-*  
19 *section (a) is modified as generally depicted on the map*  
20 *referred to as ‘Fort Scott National Historic Site Proposed*  
21 *Boundary Modification’, numbered 471/80,057, and dated*  
22 *February 2016.*

23 *“(c) LAND ACQUISITION.—The Secretary of the Inte-*  
24 *rior is authorized to acquire land and interests in land*  
25 *within the boundaries of the Fort Scott National Historic*

1 *Site by donation or exchange only. The Secretary may not*  
2 *acquire by condemnation any land or interests in land*  
3 *within the boundaries of the Fort Scott National Historic*  
4 *Site. No private property or non-Federal property shall be*  
5 *included within the boundaries of the Fort Scott National*  
6 *Historic Site without the written consent of the owner of*  
7 *such property.*

8       “(d) *NO BUFFER ZONE CREATED.—Nothing in this*  
9 *Act, the establishment of the Fort Scott National Historic*  
10 *Site, or the management plan for the Fort Scott National*  
11 *Historic Site, shall be construed to create a buffer zone out-*  
12 *side of the Fort Scott National Historic Site. That activities*  
13 *or uses can be seen, heard or detected from areas within*  
14 *the Fort Scott National Historic Site shall not preclude,*  
15 *limit, control, regulate, or determine the conduct or man-*  
16 *agement of activities or uses outside of the Fort Scott Na-*  
17 *tional Historic Site.”.*
