# **A BILL**

To direct the Securities and Exchange Commission to revise Form S-3 so as to add listing and registration of a class of common equity securities on a national securities exchange as an additional basis for satisfying the requirements of General Instruction I.B.1. of such form and to remove such listing and registration as a requirement of General Instruction I.B.6. of such form.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Accelerating Access  
5 to Capital Act of 2015”.

6 **SEC. 2. EXPANDED ELIGIBILITY FOR USE OF FORM S-3.**

7        Not later than 45 days after the date of the enact-  
8 ment of this Act, the Securities and Exchange Commission  
9 shall revise Form S-3—

10            (1) so as to permit securities to be registered  
11 pursuant to General Instruction I.B.1. of such form  
12 provided that either—

13                    (A) the aggregate market value of the vot-  
14 ing and non-voting common equity held by non-  
15 affiliates of the registrant is \$75,000,000 or  
16 more; or

17                    (B) the registrant has at least one class of  
18 common equity securities listed and registered  
19 on a national securities exchange; and

20            (2) so as to remove the requirement of para-  
21 graph (c) from General Instruction I.B.6. of such  
22 form.
