A BILL

To reauthorize the National Forest Foundation Act, and
for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Forest Foun-
5 dation Reauthorization Act of 2015”.

6 **SEC. 2. NATIONAL FOREST FOUNDATION ACT REAUTHOR-**
7 **IZATION.**

8 (a) EXTENSION OF AUTHORITY TO PROVIDE MATCH-
9 ING FUNDS FOR ADMINISTRATIVE AND PROJECT EX-
10 PENSES.—Section 405(b) of the National Forest Founda-
11 tion Act (16 U.S.C. 583j–3(b)) is amended by striking
12 “for a period of five years beginning October 1, 1992”
13 and inserting “during fiscal years 2016 through 2018”.

14 (b) AUTHORIZATION OF APPROPRIATIONS.—Section
15 410(b) of the National Forest Foundation Act (16 U.S.C.
16 583j–8(b)) is amended by striking “during the five-year
17 period” and all that follows through “\$1,000,000 annu-
18 ally” and inserting “there are authorized to be appro-
19 priated \$3,000,000 for each of fiscal years 2016 through
20 2018”.

21 (c) *TECHNICAL CORRECTIONS.*—

22 (1) *AGENT.*—Section 404(b) of the National For-
23 *est Foundation Act (16 U.S.C. 583j–2(b)) is amended*
24 *by striking “under this paragraph” and inserting “by*
25 *subsection (a)(4)”.*

1 (2) *ANNUAL REPORT.*—*Section 407(b) of the Na-*
2 *tional Forest Foundation Act (16 U.S.C. 583j–5(b)) is*
3 *amended by striking the comma after “The Founda-*
4 *tion shall”.*
