A BILL

To require the Secretary of the Interior to take land into trust for certain Indian tribes, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Nevada Native Nations*
 5 *Land Act”.*

6 **SEC. 2. DEFINITION OF SECRETARY.**

7 *In this Act, the term “Secretary” means the Secretary*
 8 *of the Interior.*

9 **SEC. 3. CONVEYANCE OF LAND TO BE HELD IN TRUST FOR**
 10 **CERTAIN INDIAN TRIBES.**

11 *(a) CONVEYANCE OF LAND TO BE HELD IN TRUST FOR*
 12 *THE FORT MCDERMITT PAIUTE AND SHOSHONE TRIBE.—*

13 *(1) DEFINITION OF MAP.—In this subsection, the*
 14 *term “map” means the map entitled “Fort*
 15 *McDermitt Indian Reservation Expansion Act”,*
 16 *dated February 21, 2013, and on file and available*
 17 *for public inspection in the appropriate offices of the*
 18 *Bureau of Land Management.*

19 *(2) CONVEYANCE OF LAND.—Subject to valid ex-*
 20 *isting rights, all right, title, and interest of the*
 21 *United States in and to the land described in para-*
 22 *graph (3)—*

23 *(A) is held in trust by the United States for*
 24 *the benefit of the Fort McDermitt Paiute and*
 25 *Shoshone Tribe; and*

1 *(B) shall be part of the reservation of the*
 2 *Fort McDermitt Paiute and Shoshone Tribe.*

3 *(3) DESCRIPTION OF LAND.—The land referred*
 4 *to in paragraph (2) is the approximately 19,094*
 5 *acres of land administered by the Bureau of Land*
 6 *Management as generally depicted on the map as*
 7 *“Reservation Expansion Lands”.*

8 *(b) CONVEYANCE OF LAND TO BE HELD IN TRUST FOR*
 9 *THE SHOSHONE PAIUTE TRIBES.—*

10 *(1) DEFINITION OF MAP.—In this subsection, the*
 11 *term “map” means the map entitled “Mountain City*
 12 *Administrative Site Proposed Acquisition”, dated*
 13 *July 29, 2013, and on file and available for public*
 14 *inspection in the appropriate offices of the Forest*
 15 *Service.*

16 *(2) CONVEYANCE OF LAND.—Subject to valid ex-*
 17 *isting rights and paragraph (4), all right, title, and*
 18 *interest of the United States in and to the land de-*
 19 *scribed in paragraph (3)—*

20 *(A) is held in trust by the United States for*
 21 *the benefit of the Shoshone Paiute Tribes of the*
 22 *Duck Valley Indian Reservation; and*

23 *(B) shall be part of the reservation of the*
 24 *Shoshone Paiute Tribes of the Duck Valley In-*
 25 *dian Reservation.*

1 (3) *DESCRIPTION OF LAND.*—*The land referred*
 2 *to in paragraph (2) is the approximately 82 acres of*
 3 *land administered by the Forest Service as generally*
 4 *depicted on the map as “Proposed Acquisition Site”.*

5 (4) *CONDITION ON CONVEYANCE.*—*The convey-*
 6 *ance under paragraph (2) shall be subject to the res-*
 7 *ervation of an easement on the conveyed land for a*
 8 *road to provide access to adjacent National Forest*
 9 *System land for use by the Forest Service for admin-*
 10 *istrative purposes.*

11 (5) *FACILITIES AND IMPROVEMENTS.*—*The Sec-*
 12 *retary of Agriculture (acting through the Chief of the*
 13 *Forest Service) shall convey to the Shoshone Paiute*
 14 *Tribes of the Duck Valley Indian Reservation any ex-*
 15 *isting facilities or improvements to the land described*
 16 *in paragraph (3).*

17 (c) *CONVEYANCE OF LAND TO BE HELD IN TRUST FOR*
 18 *THE SUMMIT LAKE PAIUTE TRIBE.*—

19 (1) *DEFINITION OF MAP.*—*In this section, the*
 20 *term “map” means the map entitled “Summit Lake*
 21 *Indian Reservation Conveyance”, dated February 28,*
 22 *2013, and on file and available for public inspection*
 23 *in the appropriate offices of the Bureau of Land*
 24 *Management.*

1 (2) *CONVEYANCE OF LAND.*—Subject to valid ex-
2 isting rights, all right, title, and interest of the
3 United States in and to the land described in para-
4 graph (3)—

5 (A) is held in trust by the United States for
6 the benefit of the Summit Lake Paiute Tribe;
7 and

8 (B) shall be part of the reservation of the
9 Summit Lake Paiute Tribe.

10 (3) *DESCRIPTION OF LAND.*—The land referred
11 to in paragraph (2) is the approximately 941 acres
12 of land administered by the Bureau of Land Manage-
13 ment as generally depicted on the map as “Reserva-
14 tion Conveyance Lands”.

15 (d) *CONVEYANCE OF LAND TO BE HELD IN TRUST FOR*
16 *THE RENO-SPARKS INDIAN COLONY.*—

17 (1) *DEFINITION OF MAP.*—In this subsection, the
18 term “map” means the map entitled “Reno-Sparks
19 Indian Colony Expansion”, dated June 11, 2014, and
20 on file and available for public inspection in the ap-
21 propriate offices of the Bureau of Land Management.

22 (2) *CONVEYANCE OF LAND.*—Subject to valid ex-
23 isting rights, all right, title, and interest of the
24 United States in and to the land described in para-
25 graph (3)—

1 (A) is held in trust by the United States for
2 the benefit of the Reno-Sparks Indian Colony;
3 and

4 (B) shall be part of the reservation of the
5 Reno-Sparks Indian Colony.

6 (3) *DESCRIPTION OF LAND.*—The land referred
7 to in paragraph (2) is the approximately 13,434
8 acres of land administered by the Bureau of Land
9 Management as generally depicted on the map as
10 “RSIC Amended Boundary”.

11 (e) *CONVEYANCE OF LAND TO BE HELD IN TRUST FOR*
12 *THE PYRAMID LAKE PAIUTE TRIBE.*—

13 (1) *MAP.*—In this subsection, the term “map”
14 means the map entitled “Pyramid Lake Indian Res-
15 ervation Expansion”, dated April 13, 2015, and on
16 file and available for public inspection in the appro-
17 priate offices of the Bureau of Land Management.

18 (2) *CONVEYANCE OF LAND.*—Subject to valid ex-
19 isting rights, all right, title, and interest of the
20 United States in and to the land described in para-
21 graph (3)—

22 (A) is held in trust by the United States for
23 the benefit of the Pyramid Lake Paiute Tribe;
24 and

1 (B) shall be part of the reservation of the
2 Pyramid Lake Paiute Tribe.

3 (3) *DESCRIPTION OF LAND.*—The land referred
4 to in paragraph (2) is the approximately 6,357 acres
5 of land administered by the Bureau of Land Manage-
6 ment as generally depicted on the map as “Reserva-
7 tion Expansion Lands”.

8 (f) *CONVEYANCE OF LAND TO BE HELD IN TRUST FOR*
9 *THE DUCKWATER SHOSHONE TRIBE.*—

10 (1) *MAP.*—In this subsection, the term “map”
11 means the map entitled “Duckwater Reservation Ex-
12 pansion”, dated October 15, 2015, and on file and
13 available for public inspection in the appropriate of-
14 fices of the Bureau of Land Management.

15 (2) *CONVEYANCE OF LAND.*—Subject to valid ex-
16 isting rights, all right, title, and interest of the
17 United States in and to the land described in para-
18 graph (3)—

19 (A) is held in trust by the United States for
20 the benefit of the Duckwater Shoshone Tribe; and

21 (B) shall be part of the reservation of the
22 Duckwater Shoshone Tribe.

23 (3) *DESCRIPTION OF LAND.*—The land referred
24 to in paragraph (2) is the approximately 31,229
25 acres of land administered by the Bureau of Land

1 *Management as generally depicted on the map as*
 2 *“Reservation Expansion Lands”.*

3 *(g) REVOCATION OF PUBLIC LAND ORDERS.—Any*
 4 *public land order that withdraws any portion of land con-*
 5 *veyed to an Indian tribe under this section shall be revoked*
 6 *to the extent necessary to permit the conveyance of the land.*

7 **SEC. 4. ADMINISTRATION.**

8 *(a) SURVEY.—Not later than 180 days after the date*
 9 *of enactment of this Act, the Secretary shall complete a sur-*
 10 *vey of the boundary lines to establish the boundaries of the*
 11 *land taken into trust for each Indian tribe under section*
 12 *3.*

13 *(b) USE OF TRUST LAND.—*

14 *(1) GAMING.—Land taken into trust under sec-*
 15 *tion 3 shall not be eligible, or considered to have been*
 16 *taken into trust, for class II gaming or class III gam-*
 17 *ing (as those terms are defined in section 4 of the In-*
 18 *dian Gaming Regulatory Act (25 U.S.C. 2703)).*

19 *(2) THINNING; LANDSCAPE RESTORATION.—With*
 20 *respect to the land taken into trust under section 3,*
 21 *the Secretary, in consultation and coordination with*
 22 *the applicable Indian tribe, may carry out any fuel*
 23 *reduction and other landscape restoration activities,*
 24 *including restoration of sage grouse habitat, on the*

- 1 *land that is beneficial to the Indian tribe and the Bu-*
- 2 *reau of Land Management.*
