Mr. MACARTHUR (for himself, Mrs. CAROLYN B. MALONEY of New York, Mr. CALVERT, Mr. KING of New York, and Mr. NADLER) introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To designate the National September 11 Memorial located at the World Trade Center site in New York City, New York, as a national memorial, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National 9/11 Memo-
5 rial at the World Trade Center Act”.

6 **SEC. 2. NATIONAL 9/11 MEMORIAL.**

7 (a) DEFINITIONS.—For the purposes of this Act—

8 (1) the term “Foundation” means the National
9 September 11 Memorial and Museum at the World

1 Trade Center Foundation, Inc., also known as the
2 National September 11 Memorial and Museum at
3 the World Trade Center;

4 (2) the term “map” means the map titled “Na-
5 tional September 11 Memorial Proposed Boundary”,
6 numbered 903/128928, and dated June 2015;

7 (3) the term “National September 11 Memo-
8 rial” means the area approximately bounded by Ful-
9 ton, Greenwich, Liberty and West Streets as gen-
10 erally depicted on the map; and

11 (4) the term “Secretary” means the Secretary
12 of the Interior.

13 (b) DESIGNATION.—The National September 11 Me-
14 morial is hereby designated as a national memorial.

15 (c) MAP.—The map shall be available for public in-
16 spection and kept of file at—

17 (1) the appropriate office of the Secretary of
18 the Interior; and

19 (2) the headquarters of the Foundation.

20 (d) GRANTS.—The Secretary may award a grant of
21 not more than \$25,000,000 each fiscal year to the Foun-
22 dation for the operation and maintenance of the National
23 9/11 Memorial.

24 (e) REPORTS.—Not later than 30 days after the end
25 of each fiscal year in which the Foundation obligates or

1 expends any part of a grant under this section, the Foun-
2 dation shall prepare and submit to the Secretary and Con-
3 gress a report that shall—

4 (1) specify the amount of grant funds obligated
5 or expended;

6 (2) specify the purpose for which the funds
7 were obligated and expended; and

8 (3) include any other information the Secretary
9 may require.

10 (f) TERMINATION OF AUTHORIZATION.—Subsections
11 (d) and (e) shall expire on the date that is 7 years after
12 the date of the enactment of this Act.

13 (g) EFFECT OF DESIGNATION.—The national memo-
14 rial designated by this section is not a unit of the National
15 Park System and the designation of the national memorial
16 shall not be construed to require or authorize Federal
17 funds to be expended for any purpose related to the na-
18 tional memorial, except under subsection (d) of this Act.
