A BILL

To direct the Federal Communications Commission to commence proceedings related to the resiliency of critical telecommunications networks during times of emergency, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Securing Access to Net-*
5 *works in Disasters Act”.*

6 **SEC. 2. STUDY ON NETWORK RESILIENCY.**

7 *Not later than 36 months after the date of enactment*
8 *of this Act, the Commission shall submit to Congress, and*
9 *make publically available on the Commission’s website, a*
10 *study on—*

11 *(1) making telecommunications service provider-*
12 *owned WiFi access points, and other communications*
13 *technologies operating on unlicensed spectrum, avail-*
14 *able to the general public for access to 911 services,*
15 *without requiring any login credentials, during times*
16 *of emergency when mobile service is unavailable; and*

17 *(2) whether non-telecommunications service pro-*
18 *vider-owned WiFi access points can provide public*
19 *access to 911 services during times of emergency.*

20 **SEC. 3. ACCESS TO ESSENTIAL SERVICE PROVIDERS DUR-**
21 **ING FEDERALLY DECLARED EMERGENCIES.**

22 *Section 427(a)(1)(A) of the Robert T. Stafford Disaster*
23 *Relief and Emergency Assistance Act (42 U.S.C.*
24 *5189e(a)(1)(A)) is amended by striking “telecommuni-*
25 *cations service” and inserting “wireline or mobile telephone*

1 *service, Internet access service, radio or television broad-*
2 *casting, cable service, or direct broadcast satellite service”.*

3 **SEC. 4. DEFINITIONS.**

4 *As used in this Act and for purposes of the rules re-*
5 *quired by this Act—*

6 (1) *the term “Commission” means the Federal*
7 *Communications Commission;*

8 (2) *the term “mobile service” means commercial*
9 *mobile service (as defined in section 332 of the Com-*
10 *munications Act of 1934 (47 U.S.C. 332)) or commer-*
11 *cial mobile data service (as defined in section 6001 of*
12 *the Middle Class Tax Relief and Job Creation Act of*
13 *2012 (47 U.S.C. 1401));*

14 (3) *the term “WiFi access point” means wireless*
15 *Internet access using the standard designated as*
16 *802.11 or any variant thereof; and*

17 (4) *the term “times of emergency” means either*
18 *an emergency as defined in section 102 of the Robert*
19 *T. Stafford Disaster Relief and Emergency Assistance*
20 *Act (42 U.S.C. 5122), or an emergency as declared by*
21 *the governor of a State or territory of the United*
22 *States.*

Amend the title so as to read: “A bill to direct the Federal Communications Commission to conduct a study on network resiliency during times of emergency, and for other purposes.”.
