A BILL

To require an independent review of the operation and administration of the Terrorist Screening Database (TSDB) maintained by the Federal Bureau of Investigation and subsets of the TSDB, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “No Fly for Foreign*
5 *Fighters Act”.*

6 **SEC. 2. GAO STUDY ON THE TERRORIST SCREENING DATA-**
7 **BASE.**

8 *(a) IN GENERAL.—Not later than 1 year after the date*
9 *of enactment of this Act, the Comptroller General of the*
10 *United States shall conduct a study and submit, to the*
11 *Committee on the Judiciary of the House of Representatives*
12 *and the Committee on the Judiciary of the Senate, a report*
13 *on—*

14 *(1) whether past weaknesses in the operation and*
15 *administration of the Terrorist Screening Database*
16 *(hereinafter referred to as the “TSDB”) and subsets*
17 *of the TSDB have been addressed; and*

18 *(2) the extent to which existing vulnerabilities to*
19 *the United States may be addressed or mitigated*
20 *through additional changes to the TSDB and subsets*
21 *of the TSDB, thereby enhancing America’s security*
22 *and defenses.*

23 *(b) REQUIRED INFORMATION.—The study and report*
24 *under subsection (a) shall include information on the extent*
25 *to which—*

1 (1) *information is being integrated into the*
2 *TSDB from all relevant sources across the government*
3 *in a timely manner;*

4 (2) *agencies are able to comply with increased*
5 *demands for information to improve the TSDB;*

6 (3) *the TSDB, and relevant subsets of the TSDB,*
7 *are accessible to agencies, authorities, and other enti-*
8 *ties, as appropriate; and*

9 (4) *the TSDB is capable of enabling users to*
10 *identify known or suspected terrorists in the most*
11 *timely and comprehensive manner possible.*
