A BILL

To amend section 3554 of title 44, United States Code,
to provide for enhanced security of Federal information
systems, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Federal Information*
5 *Systems Safeguards Act of 2016”.*

6 **SEC. 2. AGENCY DISCRETION TO SECURE INFORMATION**
7 **TECHNOLOGY AND INFORMATION SYSTEMS.**

8 *Section 3554 of title 44, United States Code, is amend-*
9 *ed by adding at the end the following new subsection:*

10 “(f) *AGENCY DISCRETION.*—*The head of each agency*
11 *has the sole and exclusive authority, with respect to any*
12 *information technology or information system under the*
13 *control of such agency—*

14 “(1) *to take any action the agency determines to*
15 *be necessary to reduce or eliminate security weakness*
16 *and risk, including to protect the information con-*
17 *tained in the information technology or information*
18 *system; and*

19 “(2) *to take any action the agency determines to*
20 *be necessary to reduce or eliminate future security*
21 *weakness and risk, including to protect the informa-*
22 *tion contained in the information technology or infor-*
23 *mation system.”.*

1 **SEC. 3 RULE OF CONSTRUCTION.**

2 *Section 2 of this Act, which clarifies agency discretion*
3 *with respect to any information technology or information*
4 *system under control of such agency, does not modify exist-*
5 *ing law as enacted in the Consolidated Appropriations Act*
6 *of Fiscal Year 2016, Division N – Cybersecurity Act of*
7 *2015, Public Law 114–113.*
