5	SEC. 2. OMB DIRECTIVE ON MANAGEMENT OF SOFTWARE

7	(a) Definition.—In this section—					
8	(1) the term "Director" means the Director o					
9	the Office of Management and Budget; and					
10	(2) the term "executive agency" has the mean-					
11	ing given that term in section 105 of title 5, United					
12	States Code.					
13	(b) OMB DIRECTIVE.—The Director shall issue a di					
14	rective to require the Chief Information Officer of each					
15	executive agency to develop a comprehensive software li-					
16	censing policy, which shall—					
17	(1) identify clear roles, responsibilities, and cen-					
18	tral oversight authority within the executive agency					
19	for managing enterprise software license agreements					
20	and commercial software licenses; and					
21	(2) require the Chief Information Officer of					
22	each executive agency to—					
23	(A) establish a comprehensive inventory,					
24	including 80 percent of software license spend					
25	ing and enterprise licenses in the executiv					
26	agency, by identifying and collecting informa					

1	tion about software license agreements using
2	automated discovery and inventory tools;
3	(B) regularly track and maintain software
4	licenses to assist the executive agency in imple-
5	menting decisions throughout the software li-
6	cense management life cycle;
7	(C) analyze software usage and other data
8	to make cost-effective decisions;
9	(D) provide training relevant to software
10	license management;
11	(E) establish goals and objectives of the
12	software license management program of the
13	executive agency; and
14	(F) consider the software license manage-
15	ment life cycle phases, including the requisition,
16	reception, deployment and maintenance, retire-
17	ment, and disposal phases, to implement effec-
18	tive decisionmaking and incorporate existing
19	standards, processes, and metrics.

21	MENT.—
22	(1) In general.—Beginning in the first fiscal
23	year beginning after the date of enactment of this
24	Act, and in each of the following 5 fiscal years, the
25	Chief Information Officer of each executive agency

1	shall submit to the Director a report on the financial					
2	savings or avoidance of spending that resulted from					
3	improved software license management.					
4	(2) Availability.—The Director shall make
