## A BILL

To require the Secretary of Commerce to maintain and operate at least one Doppler weather radar site within 55 miles of each State capital city in the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Reducing America’s  
5 Destructive Atmospheric Risks Act” or the “RADAR  
6 Act”.

1 **SEC. 2. REQUIREMENT FOR OPERATION OF DOPPLER**  
2 **WEATHER RADAR SITES NEAR STATE CAP-**  
3 **ITAL CITIES.**

4 (a) **REQUIREMENT.**—Beginning not later than 450  
5 days after the date of the enactment of this Act, the Sec-  
6 retary of Commerce shall—

7 (1) maintain and operate at least one Doppler  
8 weather radar site within 55 miles of each State  
9 capital city in the United States; and

10 (2) ensure that each radar maintained and op-  
11 erated near a city described in paragraph (1) is  
12 available to the office of the National Weather Serv-  
13 ice that provides services to such city.

14 (b) **STANDARDS.**—The Secretary shall ensure that  
15 each radar maintained and operated under subsection (a)  
16 conforms with the same standards that apply to radars  
17 operated by the Secretary, acting through the Adminis-  
18 trator of the National Oceanic and Atmospheric Adminis-  
19 tration, on the day before the date of the enactment of  
20 this Act, including standards relating to the use of dual-  
21 polarization technology or other technologies included in  
22 Weather Surveillance Radar, 1988, Doppler (WSR-88D)  
23 radars.

24 (c) **CONSIDERATIONS.**—When determining the loca-  
25 tion for constructing a radar to meet the requirements of  
26 subsection (a), the Secretary shall take into consideration

1 nearby counties that have populations of more than  
2 130,000 and do not otherwise have radar beam coverage  
3 below 10,000 feet from Weather Surveillance Radar,  
4 1988, Doppler (WSR-88D) radars.

5 (d) REPORT.—

6 (1) IN GENERAL.—Not later than 180 days  
7 after the date of the enactment of this Act, the Sec-  
8 retary shall submit to Congress a report detailing  
9 the Doppler weather radar sites that need to be con-  
10 structed or acquired in order to meet the require-  
11 ment of subsection (a).

12 (2) CONTENTS.—The report submitted under  
13 paragraph (1) shall include the following:

14 (A) Feasible locations for placement and  
15 construction of radar sites, determined by the  
16 Secretary to provide the necessary meteorolog-  
17 ical capabilities to best protect a city described  
18 in subsection (a).

19 (B) A timeline for when construction or  
20 acquisition of each radar site will be complete.

21 (e) DEFINITION.—In this Act, the term “State”  
22 means one of the 50 States.
