A BILL

To repeal the Patient Protection and Affordable Care Act and health care-related provisions in the Health Care and Education Reconciliation Act of 2010, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REPEAL OF PPACA AND HEALTH CARE-RE-**
2 **LATED PROVISIONS IN THE HEALTH CARE**
3 **AND EDUCATION RECONCILIATION ACT OF**
4 **2010.**

5 (a) PPACA.—Effective as of the enactment of the
6 Patient Protection and Affordable Care Act (Public Law
7 111–148), such Act is repealed, and the provisions of law
8 amended or repealed by such Act are restored or revived
9 as if such Act had not been enacted.

10 (b) HEALTH CARE-RELATED PROVISIONS IN THE
11 HEALTH CARE AND EDUCATION RECONCILIATION ACT OF
12 2010.—Effective as of the enactment of the Health Care
13 and Education Reconciliation Act of 2010 (Public Law
14 111–152), title I and subtitle B of title II of such Act
15 are repealed, and the provisions of law amended or re-
16 pealed by such title or subtitle, respectively, are restored
17 or revived as if such title and subtitle had not been en-
18 acted.

19 **SEC. 2. BUDGETARY EFFECTS OF THIS ACT.**

20 The budgetary effects of this Act, for the purpose of
21 complying with the Statutory Pay-As-You-Go Act of 2010,
22 shall be determined by reference to the latest statement
23 titled “Budgetary Effects of PAYGO Legislation” for this
24 Act, submitted for printing in the Congressional Record
25 by the Chairman of the Committee on the Budget of the

1 House of Representatives, as long as such statement has
2 been submitted prior to the vote on passage of this Act.

3 **SEC. 3. REPORTING REPLACEMENT LEGISLATION.**

4 The Committee on Education and the Workforce, the
5 Committee on Energy and Commerce, the Committee on
6 the Judiciary, and the Committee on Ways and Means of
7 the House of Representatives shall each report to the
8 House of Representatives legislation proposing changes to
9 existing law within each committee's jurisdiction with pro-
10 visions that—

11 (1) foster economic growth and private sector
12 job creation by eliminating job-killing policies and
13 regulations;

14 (2) lower health care premiums through in-
15 creased competition and choice;

16 (3) preserve a patient's ability to keep his or
17 her health plan if he or she likes it;

18 (4) provide people with pre-existing conditions
19 access to affordable health coverage;

20 (5) reform the medical liability system to re-
21 duce unnecessary and wasteful health care spending;

22 (6) increase the number of insured Americans;

23 (7) protect the doctor-patient relationship;

24 (8) provide the States greater flexibility to ad-
25 minister Medicaid programs;

1 (9) expand incentives to encourage personal re-
2 sponsibility for health care coverage and costs;

3 (10) prohibit taxpayer funding of abortions and
4 provide conscience protections for health care pro-
5 viders;

6 (11) eliminate duplicative government programs
7 and wasteful spending; or

8 (12) do not accelerate the insolvency of entitle-
9 ment programs or increase the tax burden on Ameri-
10 cans.
