3 **SECTION 1. SUPPORT FOR HUMAN RIGHTS AND DEMOC-**
4 **RACY PROGRAMS.**

5 Section 102(b)(1) of the North Korean Human
6 Rights Act of 2004 (22 U.S.C. 7812(b)(1)) is amended
7 by striking “2017” and inserting “2022”.

1 **SEC. 2. ACTIONS TO PROMOTE FREEDOM OF INFORMA-**
2 **TION.**

3 Subsections (b)(1) and (c) of section 104 of the
4 North Korean Human Rights Act of 2004 (22 U.S.C.
5 7814) are amended by striking “2017” and inserting
6 “2022” each place it appears.

7 **SEC. 3. SPECIAL ENVOY ON NORTH KOREAN HUMAN**
8 **RIGHTS ISSUES.**

9 Section 107(d) of the North Korean Human Rights
10 Act of 2004 (22 U.S.C. 7817(d)) is amended by striking
11 “2017” and inserting “2022”.

12 **SEC. 4. REPORT ON UNITED STATES HUMANITARIAN AS-**
13 **SISTANCE.**

14 Section 201(a) of the North Korean Human Rights
15 Act of 2004 (22 U.S.C. 7831(a)) is amended, in the mat-
16 ter preceding paragraph (1), by striking “2017” and in-
17 serting “2022”.

18 **SEC. 5. ASSISTANCE PROVIDED OUTSIDE OF NORTH**
19 **KOREA.**

20 Section 203(c)(1) of the North Korean Human
21 Rights Act of 2004 (22 U.S.C. 7833(c)(1)) is amended
22 by striking “2013 through 2017” and inserting “2018
23 through 2022”.

24 **SEC. 6. ANNUAL REPORTS.**

25 Section 305(a) of the North Korean Human Rights
26 Act of 2004 (22 U.S.C. 7845(a)) is amended, in the mat-

1 ter preceding paragraph (1) by striking “2017” and in-
2 serting “2022”.
