1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Overtime Pay for Se-
- 3 cret Service Agents Act of 2016".
- 4 SEC. 2. PREMIUM PAY EXCEPTION IN 2016 FOR WORK AU-
- 5 THORIZED UNDER SECTION 3056 OF TITLE 18.
- 6 (a) IN GENERAL.—Notwithstanding any other provi-
- 7 sion of law, including section 5307 of title 5, United States
- 8 Code, and subject to subsection (b), during calendar year
- 9 2016—
- 10 (1) section 5547(a) of such title shall not apply
- to an employee who performs work authorized by
- section 3056(a) of title 18, United States Code; and
- 13 (2) such an employee may be paid premium pay
- to the extent that the payment of such pay does not
- cause the total of basic pay and such premium pay
- 16 for any pay period for such employee to exceed the
- annual rate of basic pay payable to level II of the
- 18 Executive Schedule under section 5313 of title 5,
- 19 United States Code.
- 20 (b) Treatment of Additional Pay.—To the ex-
- 21 tent that subsection (a) results in payment of additional
- 22 premium pay of a type that is normally creditable as basic
- 23 pay for retirement or any other purpose, such additional
- 24 pay shall not be considered to be basic pay for any purpose
- 25 and shall not be used in computing a lump-sum payment

- 1 for accumulated and accrued annual leave under section
- 2 5551 of title 5, United States Code.
- 3 (c) Definition.—In this section, the term "em-
- 4 ployee" means any special agent of the United States Se-
- 5 cret Service that is a law enforcement officer, but does
- 6 not include—
- 7 (1) a member of the United States Secret Serv-
- 8 ice Uniformed Division; or
- 9 (2) an officer, employee, agent, or law enforce-
- ment officer of any other Federal agency.
- 11 (d) Conforming Amendment.—Section 118 of the
- 12 Treasury and General Government Appropriations Act,
- 13 2001 (Public Law 106–554) is amended by inserting "and
- 14 except as provided in section 2 of the Overtime Pay for
- 15 Secret Service Agents Act of 2016," after "Hereafter,".
