To designate facilities of the United States Postal Service,
to establish new ZIP Codes, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. POST OFFICE DESIGNATIONS.**

4 (a) SPECIAL WARFARE OPERATOR MASTER CHIEF
5 PETTY OFFICER (SEAL) LOUIS “LOU” J. LANGLAIS
6 POST OFFICE BUILDING.—

7 (1) DESIGNATION.—The facility of the United
8 States Postal Service located at 1221 State Street,
9 Suite 12, Santa Barbara, California, shall be known
10 and designated as the “Special Warfare Operator
11 Master Chief Petty Officer (SEAL) Louis ‘Lou’ J.
12 Langlais Post Office Building”.

13 (2) REFERENCES.—Any reference in a law,
14 map, regulation, document, paper, or other record of
15 the United States to the facility referred to in para-
16 graph (1) shall be deemed to be a reference to the
17 “Special Warfare Operator Master Chief Petty Offi-
18 cer (SEAL) Louis ‘Lou’ J. Langlais Post Office
19 Building”.

20 (b) RICHARD ALLEN CABLE POST OFFICE.—

21 (1) DESIGNATION.—The facility of the United
22 States Postal Service located at 23323 Shelby Road
23 in Shelby, Indiana, shall be known and designated
24 as the “Richard Allen Cable Post Office”.

1 (2) REFERENCES.—Any reference in a law,
2 map, regulation, document, paper, or other record of
3 the United States to the facility referred to in para-
4 graph (1) shall be deemed to be a reference to the
5 “Richard Allen Cable Post Office”.

6 (c) LEONARD MONTALTO POST OFFICE BUILDING.—

7 (1) DESIGNATION.—The facility of the United
8 States Postal Service located at 3031 Veterans Road
9 West in Staten Island, New York, shall be known
10 and designated as the “Leonard Montalto Post Of-
11 fice Building”.

12 (2) REFERENCES.—Any reference in a law,
13 map, regulation, document, paper, or other record of
14 the United States to the facility referred to in para-
15 graph (1) shall be deemed to be a reference to the
16 “Leonard Montalto Post Office Building”.

17 (d) ARMY FIRST LIEUTENANT DONALD C. CARWILE
18 POST OFFICE BUILDING.—

19 (1) DESIGNATION.—The facility of the United
20 States Postal Service located at 401 McElroy Drive
21 in Oxford, Mississippi, shall be known and des-
22 ignated as the “Army First Lieutenant Donald C.
23 Carwile Post Office Building”.

24 (2) REFERENCES.—Any reference in a law,
25 map, regulation, document, paper, or other record of

1 the United States to the facility referred to in para-
2 graph (1) shall be deemed to be a reference to the
3 “Army First Lieutenant Donald C. Carwile Post Of-
4 fice Building”.

5 (e) E. MARIE YOUNGBLOOD POST OFFICE.—

6 (1) DESIGNATION.—The facility of the United
7 States Postal Service located at 14231 TX–150 in
8 Coldspring, Texas, shall be known and designated as
9 the “E. Marie Youngblood Post Office”.

10 (2) REFERENCES.—Any reference in a law,
11 map, regulation, document, paper, or other record of
12 the United States to the facility referred to in para-
13 graph (1) shall be deemed to be a reference to the
14 “E. Marie Youngblood Post Office”.

15 (f) ZAPATA VETERANS POST OFFICE.—

16 (1) DESIGNATION.—The facility of the United
17 States Postal Service located at 810 N. U.S. High-
18 way 83 in Zapata, Texas, shall be known and des-
19 ignated as the “Zapata Veterans Post Office”.

20 (2) REFERENCES.—Any reference in a law,
21 map, regulation, document, paper, or other record of
22 the United States to the facility referred to in para-
23 graph (1) shall be deemed to be a reference to the
24 “Zapata Veterans Post Office”.

1 (g) MARINE LANCE CORPORAL SQUIRE “SKIP”
2 WELLS POST OFFICE BUILDING.—

3 (1) DESIGNATION.—The facility of the United
4 States Postal Service located at 2886 Sandy Plains
5 Road in Marietta, Georgia, shall be known and des-
6 ignated as the “Marine Lance Corporal Squire
7 ‘Skip’ Wells Post Office Building”.

8 (2) REFERENCES.—Any reference in a law,
9 map, regulation, document, paper, or other record of
10 the United States to the facility referred to in para-
11 graph (1) shall be deemed to be a reference to the
12 “Marine Lance Corporal Squire ‘Skip’ Wells Post
13 Office Building”.

14 (h) OFFICER JOSEPH P. CALI POST OFFICE BUILD-
15 ING.—

16 (1) DESIGNATION.—The facility of the United
17 States Postal Service located at 6300 N. Northwest
18 Highway in Chicago, Illinois, shall be known and
19 designated as the “Officer Joseph P. Cali Post Of-
20 fice Building”.

21 (2) REFERENCES.—Any reference in a law,
22 map, regulation, document, paper, or other record of
23 the United States to the facility referred to in para-
24 graph (1) shall be deemed to be a reference to the
25 “Officer Joseph P. Cali Post Office Building”.

1 (i) SEGUNDO T. SABLAN AND CNMI FALLEN MILI-
2 TARY HEROES POST OFFICE BUILDING.—

3 (1) DESIGNATION.—The facility of the United
4 States Postal Service located at 1 Chalan Kanoa
5 VLG in Saipan, Northern Mariana Islands, shall be
6 known and designated as the “Segundo T. Sablan
7 and CNMI Fallen Military Heroes Post Office
8 Building”.

9 (2) REFERENCES.—Any reference in a law,
10 map, regulation, document, paper, or other record of
11 the United States to the facility referred to in para-
12 graph (1) shall be deemed to be a reference to the
13 “Segundo T. Sablan and CNMI Fallen Military He-
14 roes Post Office Building”.

15 (j) ABNER J. MIKVA POST OFFICE BUILDING.—

16 (1) DESIGNATION.—The facility of the United
17 States Postal Service located at 1101 Davis Street
18 in Evanston, Illinois, shall be known and designated
19 as the “Abner J. Mikva Post Office Building”.

20 (2) REFERENCES.—Any reference in a law,
21 map, regulation, document, paper, or other record of
22 the United States to the facility referred to in para-
23 graph (1) shall be deemed to be a reference to the
24 “Abner J. Mikva Post Office Building”.

1 **SEC. 2. ESTABLISHING NEW ZIP CODES.**

2 Not later than September 30, 2017, the United
3 States Postal Service shall designate a single, unique ZIP
4 code for, as nearly as practicable, each of the following
5 communities:

6 (1) Miami Lakes, Florida.

7 (2) Storey County, Nevada.

8 (3) Flanders, Northampton, and Riverside in
9 the Town of Southampton, New York.

10 (4) Ocoee, Florida.

11 (5) Glendale, New York.
